The Board for Financing Water Projects (BFWP) will hold a public hearing to receive comments from all interested persons regarding adoption of permanent regulations that pertain to Chapter 349 of the Nevada Administrative Code (NAC).

A Notice of Intent to Act upon a Regulation is provided pursuant to Nevada Revised Statutes 233B.0603.

Permanent Regulation R124-24: Bureau of Administrative Services, Office of Financial Assistance – Establishes and revises provisions relating to financial assistance for water projects

R124-24 is proposing to amend the NAC Chapter 349 to amend the Capital Improvement Grant Program regulations to:

1. Align with the adoption of Assembly Bill (AB) 20 (83rd Session),
2. Align with the adoption of Senate Bill (SB) 150 (82nd Session),

3. Clarify requirements for each type of recipient,
4. Streamline and clarify Letter of Intent and Application processes,
5. Update regulations for Capital Improvement Grants scale,
6. Update fee and grant term language, and
7. Clean up outdated language and processes.

Note this regulatory petition was originally scheduled for the May 20, 2026, BFWP meeting but due to public noticing issues it was pulled from the agenda for that meeting and rescheduled.

Additional Information:

The Board for Financing Water Projects (BFWP) was created by NRS 349.957. Under NRS 445A.265, the Board is charged with approving the priority of projects applying for grant assistance and the review and approval of loans to water systems applying for assistance from the Drinking Water State Revolving Fund. Under NRS 349.982, the Board is charged with the administration of the programs that provide grants for capital improvements to publicly owned water systems, grants for improvements to conserve water and grants for Technical Support for Water Rights.

Persons wishing to comment on the proposed actions of the Board for Financing Water Projects may participate in the scheduled public hearing (virtually or by phone) or may address their comments, data, views, or arguments in written form to: Office of Financial Assistance, 901 South Stewart Street, Suite 4001, Carson City, Nevada 89701-5249. The OFA must receive written submissions at least five days before the scheduled public hearing.

If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the BFWP may proceed immediately to act upon any written submissions.

Members of the public can inspect copies of the regulations to be adopted at the State Library and Archives in Carson City (100 Stewart Street), and at the offices of the Division of Environmental Protection in Carson City and Las Vegas. The Carson City office is located at 901 South Stewart Street, Suite 4001 and the Las Vegas office is located at 375 East Warm Springs Road, Suite 200.

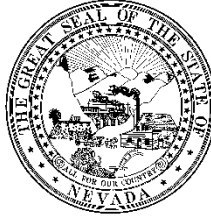

The following information is provided pursuant to the requirements of NRS 233B.0603:

1. The need for and the purpose of the proposed regulation or amendment:

The proposed regulation changes were prompted by changes to the Nevada Revised Statutes. These regulatory amendments are being proposed to align Nevada Administrative Code with Nevada Revised Statutes by expanding the list of eligible recipients of program funds to include wellhead abandonment and septic-to-sewer conversion projects and governmental bodies for the development of Water Resource Plans. The proposed amendments also clarify and streamline some processes, update fee and grant scale language, and clean up outdated language and processes to align with current practices.

2. If the proposed regulation is a temporary regulation, the terms or the substance of the proposed regulation to be adopted, amended or repealed, or a description of the subjects and issues involved:

The proposed regulation is not a temporary regulation.

3. The estimated economic effect of the regulation on the business which it is to regulate and on the public:

The proposed regulations expand the eligibility of the program. The entity or organization may or may not be a business defined by NRS 233B.0382. This proposed regulation does not introduce any new fees; however, the proposed amendments do clarify that grant funds may not be used to pay for existing program fees. The proposed regulations are not anticipated to have any significant adverse or beneficial effects to the regulated community in the short or long term. The methods used in determining the impact on a small business.

The public receives a benefit when a wastewater or stormwater system receives a grant from the program versus taking out a loan from the public market. This slight benefit is expected to affect the public in the short and long term.

The service fee may have an adverse impact on the community; however, there is a net benefit because the funds are in the form of a grant instead of a loan. The Division estimates this impact will be minimal and is expected to affect the public in the short and long term.

4. The methods used by the agency in determining the impact on a small business:

The Agency's assumptions and conclusions were covered during the public workshop process. Comment was solicited through a workshop held in Carson City and video conferenced to Las Vegas. Notices of the workshop and an invitation for comments were posted in county public libraries, the Nevada Division of Environmental Protection (NDEP) buildings in Carson City and Las Vegas, the NDEP website, the Legislative Council Bureau's website, and the official State website. The workshop notice was also emailed to an extensive distribution list maintained by NDEP's Office of Financial Assistance (OFA).

5. The estimated cost to the agency for enforcement of the proposed regulation:

The proposed changes would not have a significant impact on OFA's ability to enforce program requirements. Existing fees are collected as part of our routine semi-annual debt service collections.

6. A description of and citation to any regulations of other state or local governmental agencies which the proposed regulation overlaps or duplicates and a statement explaining why the duplication or overlapping is necessary. No. Affected entities (Nevada water systems applying for Capital Improvement Grant funds) may or may not constitute a "business" as defined by NRS 233B.0382 - the Division cannot predict whether future applicants will be affected financially. In addition, the proposed regulation expands the list of recipients eligible to receive program funds. Because the funds are grants, the customers of newly eligible recipients could receive modest economic benefit. This proposed regulation does not impose new fees; however, the proposed regulations do clarify that grant funds may not be used to pay program fees.


