

LEGISLATIVE REVIEW OF ADOPTED REGULATIONS AS REQUIRED BY
NRS 233B.066
LCB FILE R001-25

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 641.

1. A clear and concise explanation of the need for the adopted regulation.

This regulation was prepared to revise the continuing education requirements for licensure renewal to expand the options for the continuing education required for licensure renewal to include Continuing Professional Development (CPD) in addition to the continuing education programs currently provided in NAC 641.136.

2. A description of how public comment was solicited, a summary of public response, and an explanation of how other interested persons may obtain a copy of the summary.

Notices of public workshops and notices of intent to act upon the regulation were sent to persons who were known to have interest in the continuing education requirements for licensure renewal, to the Board's licensees, and to any specific person who requested notification regarding regulation changes. That distribution included further information on how to receive a free copy of the proposed regulation. These documents were also made available through the website of the Board of Psychological Examiners (psyexam.nv.gov) or by directly emailing the Board office (NBOP@govmail.state.nv.us), and were posted at the following location:

The Board held public workshops on October 11, 2024, December 6, 2024, and January 10, 2025, to discuss the proposed change to the current NAC Chapter 641. During those workshops, the Board received both written and verbal public comment from members of the public in attendance who:

- Appreciated the efforts to provide for more options for continuing education;
- Requested non-binary language in the regulation language
- Sought to clarify the revisions in relation to the number and types of continuing education hours required for renewal
- Shared concern for the financial burden of continuing education requirements on new graduates and early career psychologists
- Disagreed with the proposed language that included pro bono work as Continuing Professional Development
- Requested that the Continuing Professional Development related to teaching be expanded:
 - o to other behavioral health professions,

- beyond clinical courses, and
- to gradual (not just doctoral) level classes.

The minutes of those meetings, which can be obtained by contacting the Board office or locating them on the Board's website (psyexam.nv.gov), contain a summary of the discussion regarding the proposed changes.

On September 9, 2025, and November 10, 2025, the Board issued and posted Notices of Intent to Act Upon a Regulation, which incorporated the proposed regulation change that the Board discussed at its October 11, 2024, December 6, 2025, and January 10, 2025, regulations workshops. Those notices included a request for submission of public comment regarding adoption of the regulation.

On October 24, 2025, and December 12, 2025, after the Board received an approved R001-25 draft from the Legislative Counsel Bureau, the Board conducted public hearings on R001-25 during its regular Board meetings. Though the Board received verbal public comment on the proposed regulation, there was no opposition to the adoption of the regulation. The Board approved the adoption of proposed regulation R001-25 at the conclusion of the December 12, 2025, hearing on that regulation.

December 12, 2025:

Dr. Tatsiana Razzhavaikina was also the only member of the public who provided comment during the Board's December 12, 2025, hearing, which had been continued from the October 24, 2025, hearing in order to, among other things, respond to the inquiries Dr. Razzhavaikina had during the October 24, 2025, hearing regarding her written public comment that was part of the December 6, 2024, regulation workshop. Dr. Razzhavaikina's public comment during the December 12, 2025, meeting was in the form of gratitude for the work the Board put into expanding continuing education options to include Continuing Professional Development. The contact information provided on the Dr. Razzhavaikina's written public comment for the December 6, 2024, workshop is provided above.

5. A description of how comment was solicited from affected business, a summary of their response, and an explanation of how other interested persons may obtain a copy of the summary.

The Board solicited comments from affected businesses in the same manner as they were solicited from the public. Notices of the public workshops and notices of the Board's intent to act upon the regulation were sent to persons who were known to have interest in the continuing education requirements for licensure renewal, to the Board's licensees, and to any specific person who requested notification regarding regulation changes. The summary of the Board's discussion may be obtained through the minutes, which will be provided and/or made available by contacting the Board office or locating them on the Board's website (psyexam.nv.gov). The Board received written and verbal public comment/inquiry as noted and outlined above.

6. If the regulation was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulation without change.

As drafted, R001-25 reflected changes from the initial proposed language that had been drafted for and considered during the public workshops based upon, among other things, public comment and input during those workshops. As a result, there were no changes proposed for R001-25, and the Board approved its adoption as provided in the R001-25 LCB draft.

7. The estimated economic effect of the adopted regulation on the businesses which it is to regulate and on the public. These must be stated separately, and each case must be included:

Be that as it may, because the regulation revisions in R001-25 expand the options for licensees to complete their continuing education for renewal, there are no known or estimated immediate adverse effects from this regulation on its licensees, except to the extent that any continuing professional development options a licensee chooses for renewal for upcoming renewal periods are more expensive than the other approved continuing education options.

Adverse, long-term: The Board does not regulate businesses. Be that as it may,

because the regulation revisions in R001-25 expand the options for licensees to complete their continuing education for renewal, there are no known or estimated immediate adverse effects from this regulation on its licensees, except to the extent that any continuing professional development options a licensee chooses for renewal for upcoming renewal periods are more expensive than the other approved continuing education options.

b) Beneficial, immediate: The Board does not regulate businesses. Be that as it may, because the regulation revisions in R001-25 expand the options for licensees to complete their continuing education for renewal, there are no known or estimated immediate beneficial economic effects in this regulation, except to the extent that any continuing professional development options a licensee chooses for renewal for upcoming renewal periods are less expensive than the other approved continuing education options.

Beneficial, long-term: The Board does not regulate businesses. Be that as it may, because the regulation revisions in R001-25 expand the options for licensees to complete their continuing education for renewal, there are no known or estimated long-term beneficial economic effects in this regulation, except to the extent that any continuing professional development options a licensee chooses for renewal for upcoming renewal periods are less expensive than the other approved continuing education options.

c) Direct, immediate: The Board does not regulate businesses. Be that as it may, because the regulation revisions in R001-25 expand the options for licensees to complete their continuing education for renewal, there are no known or estimated immediate direct economic effects in this regulation, except to the extent that any continuing professional development options a licensee chooses for renewal for upcoming renewal periods are more or less expensive than the other approved continuing education options.

Direct, long-term: The Board does not regulate businesses. Be that as it may, because the regulation revisions in R001-25 expand the options for licensees to complete their continuing education for renewal, there are no known or estimated long-term direct economic effects in this regulation, except to the extent that any continuing professional development options a licensee chooses for renewal for upcoming renewal periods are more or less expensive than the other approved continuing education options.

d) Indirect, immediate: The Board does not regulate businesses. Be that as it may, because the regulation revisions in R001-25 expand the options for licensees to complete their continuing education for renewal, there are no known or estimated immediate indirect economic effects in this regulation, except to the extent that any continuing professional development options a licensee chooses for renewal for upcoming renewal periods are more or less expensive than the other approved continuing education options.

Indirect, long-term: The Board does not regulate businesses. Be that as it may, because the regulation revisions in R001-25 expand the options for licensees to complete their continuing education for renewal, there are no known or estimated long-term indirect economic effects in this regulation, except to the extent that any continuing professional development options a licensee chooses for renewal for upcoming renewal periods are more or less expensive than the other approved continuing education options.

8. The estimated cost to the agency for enforcement of the adopted regulation.

To the extent that the revised regulation would require enforcement, there will be no increased cost for enforcement of the changes.

The Board is not aware of any overlapping or duplicating of federal or state regulations.

R001-25 does not provide for a new fee or increase in an existing fee.

The State of Nevada Board of Psychological Examiners approved and adopted the regulation on December 12, 2025.
