Legislative Review of Adopted Regulations as Required by NRS 233B.066 Pertaining to NAC 389.810 of the Nevada Administrative Code (NAC).

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 389:

This proposed regulation will revise requirements establishing a joint technical skills committee. This is necessary to ensure all school districts provide resources in the best interest of student's success. Also, it is requisite from AB38 (2021).
