The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 501.

1. A clear and concise explanation of the need for the adopted regulation.

The issue this regulation aims to address is the absence of meaningful penalties for violations, which results in insufficient deterrence against the use of trail cameras and thermal imaging devices during closed seasons. Currently, the low penalties associated with such violations do not effectively discourage continued misuse, as the consequences are minimal and often deemed acceptable by violators.

Public comment was solicited at the September Wildlife Commission meeting, and members of the public were given advanced notice pursuant to OML. Members of County Advisory Boards to Manage Wildlife, animal rights groups, and members of the public generally supported the introduced regulation, with many individuals citing that they did not want to see this expanded to current wildlife that are currently allowed to be captured with these devices.
