

**LEGISLATIVE REVIEW OF ADOPTED REGULATION AS REQUIRED BY
NRS 233B.066
LCB FILE No. R058-25**

The following statement is submitted for adopted amendments to Nevada Administrative Code ("NAC") Chapter 385B.

1. A clear and concise explanation of the need for the adopted regulation.

This regulation contains revisions to NAC 385B.510 concerning the method for scoring Tennis matches. The revisions included herein update the scoring method from a 45-point system to an 18-point system. Under the 9-point system each team fields a lineup of 1, 2, or 3 singles match players and 1, 2, or 3 doubles match teams. Each singles player plays one set against all three singles players from the other team for a total of 9 sets played, and each doubles team plays one set against each doubles team of the opponent for a total of 9 sets. The combined total of all sets played is 18. The team that wins the most sets wins the match. The revisions also include a requirement that a school have a minimum of 6 players so it can fill at least two of the doubles sets. If there are less than 6 players, the school forfeits the entire match. Finally, the revision to section 7 (now section 8) as to the number of singles players and doubles teams eliminates the requirement for 32 since some regions within the state are larger or smaller than others thus making a certain limit unenforceable on a statewide basis.

The regulation also contains revisions to NAC 385B.535 regarding Girls Flag Football. This revision is necessary to comply with the National Federation of State High School ("NFHS") adoption of a rule book for Flag Football. When the NIAA adopted Girls Flag Football the NFHS did not have a rule book for the sport, so the NIAA adopted its own rules. As a member of the NFHS the NIAA is required to follow NFHS rule books in all sports, and must now do so for Girls Flag Football.

The regulation also revises NAC 385B.630 and NAC 385B.632, regarding the number of Boys and Girls Tennis participants necessary to participate in a state tournament. The revision tracks with the changes to NAC 385B.510, changing the number from 4 participants to 6 participants for each qualifying team.

2. A description of how public comment was solicited, a summary of public response, and an explanation how other interested persons may obtain a copy of the summary.

Copies of the proposed regulation and notice of intent to act upon the regulation were sent by U.S. mail and by email to persons who were known to have an interest in the subject of the governance of high school athletics in the State of Nevada, including all member schools of the NIAA, and to all persons who had specifically requested such notice. These documents were also made available at the website of the NIAA's office, www.niaa.com, as well as <https://notice.nv.gov>; and were mailed to all county libraries in Nevada and posted at the following locations:

This regulation was initially reviewed by the NIAA Board of Control on June 3 and 4, 2025 at its Summer Board Meeting. On or about August 22, 2025, the Executive Director issued a Notice of Intent to Act Upon a Regulation pursuant to NRS 233B.0603, which incorporated in the proposed amendments all discussions held at the above-described Board of Control meetings, as well as comments from LCB staff attorneys. That Notice is attached as Exhibit "1." This regulation was reviewed by the NIAA Board of Control at a board meeting held on September 23, 2025, respectively, which included the opportunity for public comment concerning the proposed amendment.

Comments were solicited from member schools of the NIAA and other persons having an interest in the governance of interscholastic high school activities in the state, as well as members of the public. The regulation was adopted on September 23, 2025 without changing any part of the proposed regulation because no request for any changes was made at the workshop or hearing.

**NOTICE OF INTENT TO ACT UPON A REGULATION
NRS 233B.0603**

The Nevada Interscholastic Activities Association (“NIAA”) will hold a public hearing starting at 1:00 p.m. on September 23, 2025, in conjunction with its regularly scheduled Board of Control meeting which is being conducted virtually with Board members participating remotely and members of the public appearing by live stream through a YouTube link as well as the NIAA website, www.niaa.com. Members of the public have been provided the opportunity to address the regulation through the virtual link. The purpose of the hearing is to receive comments from all interested persons regarding the adoption of an amendment to a Regulation that pertains to Chapter 385B of the Nevada Administrative Code.

The following is provided pursuant to the requirements of NRS 233B.0603:

1. The adoption of this amendment to Regulation is needed for purposes of the governance of high school athletics and activities throughout the State of Nevada which are governed by the NIAA.
2. The Regulation changes will address the following:
 - (a) This regulation revises NAC 385B.510 concerning the method for scoring Tennis matches. The revisions included herein update the scoring method from a 45-point system to an 18-point system. Under the 9-point system each team fields a lineup of 1, 2, or 3 singles match players and 1, 2, or 3 doubles match teams. Each singles player plays one set against all three singles players from the other team for a total of 9 sets played, and each doubles team plays one set against each doubles team of the opponent for a total of 9 sets. The combined total of all sets played is 18. The team that wins the most sets wins the match.  - (b) The regulation also contains revisions to NAC 385B.535 regarding Girls Flag Football. When the NIAA adopted Girls Flag Football the NFHS did not have a rule book for the sport, so the NIAA adopted its own rules. As a member of the NFHS the NIAA is required to follow NFHS rule books in all sports and must now do so for Girls Flag Football.
 - (c) The regulation also revises NAC 385B.630 and NAC 385B.632, regarding the number of Boys and Girls Tennis participants necessary

to participate in a state tournament. The revision tracks with the changes to NAC 385B.510, changing the number from 4 participants to 6 participants for each qualifying team.

3(a). The economic effect of the amendment of this amendment to Regulation on high school athletics will be minimal.

(b). The immediate and long-term effects of this amendment to Regulation will be to provide a better source of information to the public regarding the governance of high school athletics and activities, including high school athletes, parents, coaches and officials all of whom are governed by the NIAA.

4. The estimated cost to the NIAA for purposes of enforcement of the proposed amendment to Regulation are minimal.

5. This amendment to Regulation does not overlap or duplicate any regulations of other state or local governmental agencies.

6. The adoption of this amendment to Regulation is not required pursuant to federal law.

7. The adoption of this Regulation does not include any provisions which are more stringent than any federal regulation. *See*, paragraph 6, above.

8. The adoption of this Regulation does establish an increase in fees paid by member schools of the NIAA for governance of the NIAA.

People wishing to comment upon the proposed action of the NIAA may appear at the scheduled public hearing or may address their comments, data, views or arguments, in written form, to Timothy Jackson, Executive Director, Nevada Interscholastic Activities Association, 1188 Victorian Plaza Circle, Sparks, Nevada 89431. Written submissions must be received by the NIAA on or before September 19, 2025. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the NIAA may proceed immediately to act upon any written submissions.

A copy of this Notice and the amendment to Regulation to be adopted will be on file at the State Library, 100 Stewart Street, Carson City, Nevada for inspection by members of the public during business hours. Additional copies of the Notice and the Regulations to be adopted will be available at 1188 Victorian Plaza Circle, Sparks, Nevada 89431, and in all counties in which an office of the agency is not maintained, at the main public library, for inspection and copying by members of the public during business hours. This Notice and the text of the proposed Regulations are also available in the State of Nevada Register of Administrative Regulations, which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653, and on the internet at <http://www.leg.state.nv.us>. Copies of this Notice and the proposed Regulations will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within thirty (30) days thereafter, will issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.
