Legislative Review of Adopted Regulations per NRS 233B.066

Informational Statement Form for LCB File R070-25, Adopted by the Commission on Professional Standards in Education. The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 391:

1. A clear and concise explanation of the need for the adopted regulation:

SB175 (2025) required updates to regulation regarding endorsements to teach pupils in the Junior Reserve Officers' Training Corps. The Commission on Professional Standards is tasked with adopting regulations prescribing the qualifications for licensing teachers and educational personnel and setting forth the educational requirements a person must satisfy in order to qualify for an endorsement in a field of specialization. The Commission on Professional Standards engaged with the field and legislation to ensure that these requirements are modern, rigorous, and responsive.

2. A description of how public comment was solicited, a summary of public response, and an explanation of how other interested people may obtain a copy of the summary.

Public comment was solicited through both the regulatory workshop and public hearing. The attached workshop agenda and notice was posted 15 days prior to the workshop; the attached public hearing agenda and notice was posted 30 days prior to the public hearing. These notices were then circulated through the Department's mailing list, forwarded by programmatic leads to subject matter experts across the State, as applicable, and posted with State Library and Archives and within the Department of Education in both Las Vegas and Carson City. A description of how members of the public could provide public comments was included in both items, and at least two periods of public comment were made available during the course of the meetings. The public response can be summarized as no persons provided testimony. A copy of the summary may be obtained by contacting Amelia Thibault at athibault@doe.nv.gov. Minutes of the public hearing and/or workshop may be obtained by visiting <https://doe.nv.gov/boards-commissions-councils/commission-on-professional-standards>.

No public comment was provided specific to R070-25 at the time of the hearing or workshop.

5. A description of how comments were solicited from affected businesses, a summary of their response, and an explanation of how other interested people may obtain a copy of the summary.

This regulation regulates public education and does not have authority over private industry or small businesses. No impact on small businesses and/or private industry was identified. A small business impact letter was drafted and published along with the regulatory workshop agenda and notice 15 days prior to the workshop. There is no summary as no responses were received, and minutes are available at <https://doe.nv.gov/boards-commissions-councils/regulation-workshops-and-public-hearings>.

The Commission on Professional Standards adopted the proposed regulation at the public hearing held on April 15, 2026. No changes were required as engagements prior to the hearing (i.e., public comment, amendments, etc.) supported a quality end product requiring no further revisions.

There will be no economic effect of the regulation on the business it regulates. There is no estimated economic effect on the public. There is no adverse or beneficial effect nor immediate or long-term effect on the business that it regulates nor the public.

There is no additional cost to the agency for enforcement of this regulation.

Notice of Hearing for the Adoption of Regulations of the Commission on Professional Standards in Education

The Commission may adopt or not adopt this regulation.
