Legislative Review of Adopted Regulations per NRS 233B.066

Informational Statement Form for LCB File R083-25, Adopted by the Nevada State Board of Education

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 387:

1. A clear and concise explanation of the need for the adopted regulation:

SB460 (2025) added a previously undefined term to the eligibility requirements for funding under the Early Childhood Literacy and Readiness Account; this regulation defines the term “vulnerable and historically underserved populations” for these purposes.

2. A description of how public comment was solicited, a summary of public response, and an explanation of how other interested people may obtain a copy of the summary.

Public comment was solicited through both the regulatory workshop and public hearing. The attached workshop agenda and notice was posted 15 days prior to the workshop; the attached public hearing agenda and notice was posted 30 days prior to the public hearing. These notices were then circulated through the Department’s mailing list, forwarded by programmatic leads to subject matter experts across the State, as applicable, and posted with State Library and Archives. A description of how members of the public could provide public comments was included in both items, and at least two periods of public comment were made available during the course of the meetings.

3. The number of persons who:

- a. Attended Workshop (2) and Hearing (1)
- b. Testified at Workshop (0) and Hearing (0)
- c. Submitted Written Statements for Workshop (0) and Hearing (0)

No public comment was provided specific to R083-25.

5. A description of how comments were solicited from affected businesses, a summary of their response, and an explanation of how other interested people may obtain a copy of the summary.

This regulation regulates public education and does not have authority over private industry or small businesses. No impact on small businesses and/or private industry was identified. A small business impact letter was drafted and published along with the regulatory workshop agenda and notice 15 days prior to the workshop. Please see section 2 for further information regarding posting and

solicitation of feedback / comments.

6. If the regulation was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulation without change.

The State Board of Education adopted the proposed regulation at the public hearing held on February 25, 2026. No changes were required as engagements prior to the hearing (i.e., public comment, amendments, etc.) supported a quality end product requiring no further revisions.

7. The estimated economic effect of the adopted regulation on the business which it regulates and/or on the public. These must be stated separately and, in each case, include both adverse and beneficial effects, and both immediate and long-term effects.

There will be no economic effect of the regulation on the business it regulates. There is no estimated economic effect on the public. There is no adverse or beneficial effect nor immediate or long-term effect on the business that it regulates nor the public.

There is no additional cost to the agency for enforcement of this regulation.

Notice of Hearing for the Adoption of LCB File R083-25 by the Nevada Department of Education
