

**NEVADA STATE BOARD OF NURSING  
LEGISLATIVE REVIEW OF ADOPTED REGULATIONS  
AS REQUIRED BY NRS 233B.066  
LCB FILE R087-25**

**1. A clear and concise explanation of the need for the adopted regulation.**

This regulation is necessary following the enactment of Assembly Bill 319 at the 2025 Nevada Legislative Session to provide guidance to Advanced Practice Registered Nurses and Registered Nurses in the delegation and/or supervision of Medical Assistants.

**2. A description of how public comment was solicited, a summary of public response and an explanation how other interested persons may obtain a copy of the summary.**

A summary of the public response would be mixed. Nevada Hospitals' comments were in favor of the regulation and labor unions were in opposition to the regulation. Specifically, two Unions: National Nurses Organizing Committee - National Nurses United and Service Employees International Union provided comments in opposition to all or parts of the regulation. Representatives from two Nevada Hospitals and the Nevada Hospital Association provided comments in support of the regulation. One individual, who serves on the Nevada Advanced Practice Nurses Association and also in a Union role provided comments in support of the regulation.

On November 4, 2025, the Nevada State Board of Nursing conducted a workshop on LCB File No. R987-25. The National Nurses Organizing Committee - National Nurses United submitted one email with comments and two written comments.

On January 14, 2026, the Nevada State Board of Nursing conducted a hearing on LCB File No. R87-25. Three written comments were received.

Jonlyn Miller from National Nurses Organizing Committee - National Nurses United provided verbal comments and submitted written comments.

Chelsey Booker from National Nurses United – Nevada provided verbal comments and submitted written comments.

Nevada Advanced Practice Nurses Association submitted written comments.

The Hearing was held as an agenda item during the Nevada State Board of Nursing's January 2026 Board meeting. Appearance at the Board meeting and therefore the Hearing was possible by in person attendance and also by virtual means. This means that it is almost impossible to determine who is attending the hearing if the person mutes their microphone and turns off their camera. Then, if a person wishes to make a verbal statement, that person unmutes their microphone and makes the statement. Only then, can it be determined who that person is, and what kind of statement will be made. Telephone numbers and email addresses are not required to attend the open meeting and are rarely provided.

5. **A description of how comment was solicited from affected businesses, a summary of their response, and an explanation how other interested persons may obtain a copy of the summary.**

Public comments were received from businesses that might be impacted by the new Nevada Revised Statute that would allow Advanced Practice Registered Nurses and Registered Nurses to supervise Medication Assistants. Public Comments were solicited from health care facilities in the same way that comments were solicited from the general public.

Interested persons may obtain a copy of the summary of the public comments sought from businesses by accessing the Nevada State Board of Nursing's website where all the information regarding the regulatory process can be found. Additionally, any interested person can call or drop by either of the Board's offices to discuss the regulation, or look at any of the written minutes of the meetings, workshops, and hearings on the regulation.

6. **If the regulation was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulation without change.**

The original language approved by the Board was submitted to the Legislative Counsel Bureau. Although refined by the Legislative Counsel Bureau, the language did not materially change the meaning and intent of the original language. Therefore, the Board adopted it without change.

7. **The estimated economic effect of the adopted regulation on the businesses which it is to regulate and on the public. These must be stated separately, and each case must include:**

- (a) Both adverse and beneficial effects on the businesses which it is to regulate.

#### Adverse Effects

The Nevada State Board of Nursing does not anticipate any adverse economic impact from this regulation on businesses it is to regulate. Comments were provided about public safety and the impact on an individual nursing license, but overall the effects would not be an impact on businesses.

#### Beneficial Effects

The beneficial effects of this regulation on businesses it is to regulate will be that perhaps businesses that employ Advanced Practice Registered Nurses and Registered Nurses may hire more Medical Assistants now that supervision and delegation may occur.

Both adverse and beneficial effects on the public.

#### Adverse Effects

The Nevada State Board of Nursing does not anticipate any adverse economic impact from this regulation on the public. The comments balanced between those comments supporting greater access to healthcare and those comments that claimed the delegation would be negative to nursing licensure.

#### Beneficial Effects

The beneficial effects of this regulation on the public will be that perhaps businesses that employ Advanced Practice Registered Nurses and Registered Nurses may hire more Medical Assistants now that supervision and delegation may occur.

(b) Both immediate and long-term effects on the businesses which it is to regulate.

#### Immediate Effects

The Immediate Effects of the regulation would be is to protect public health through the addition of health care providers that can be part of the health care team with the new ability to receive delegated tasks.

#### Long-Term Effects

The long-term effects would be the same as the Immediate Effects of the regulation.

Both immediate and long-term effects on the public.

#### Immediate Effects

The Immediate Effects of the regulation on the public would be the additional hiring of additional health care providers that can be part of the health care team with the new ability to receive delegated tasks.

#### Long-Term Effects

The long-term effects would be the same as the Immediate Effects of the regulation.

There is no additional cost to the Nevada State Board of Nursing for enforcement of this regulation.
