LEGISLATIVE REVIEW OF ADOPTED REGULATIONS AS REQUIRED BY NRS 233b.066
LCB FILE No. R096-25RP1

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 656.

1. The passage of Senate Bill 191 at the 2025 Legislative Session allows the Board to adopt their fee structure through regulation. This regulation is necessary to provide specific fees relating to license and certificate registrations, renewals and exam fees.
2. Copies of the proposed regulations, notice of workshop and notice of intent to act upon the regulation were sent by email to persons who were known to have an interest in the subject of court reporting as well as any persons who had specifically requested such notice. A workshop was held on April 27, 2026 and the minutes of that meeting, attached hereto, contain a summary of the discussion held regarding the proposed amendments. Thereafter, on July 9, 2026, the Executive Secretary issued a Notice of Intent to Act Upon a Regulation.

 - (c) Submitted written comments: No written comments were submitted.
4. A list of names and contact information for each person identified above in #3, is attached as Exhibit A.
5. Notices of the workshop and adoption hearing to solicit comments were sent out to each active court reporter and designated firm representative registered with the State of Nevada Certified Court Reporters Board. The notice instructed interested persons to contact the Executive Secretary to submit their comments or request a copy of the materials. No comments were submitted.
6. The regulation was adopted on October 25, 2023 without change because the Board was not made aware of any information or comments that would indicate a need for changing the language of the proposed regulation.

7. The Board does not anticipate any adverse economic effect on the amended regulations. The immediate and long-term effects will keep NAC Chapter 656 consistent with NRS Chapter 656 and will provide a fee structure for Nevada court reporters, court reporting firms and exam applicants.
8. There is no additional cost to the Board to enforce this regulation.
9. There are no other state or governmental agency regulations that the regulation duplicates.
10. There are no federal regulations that apply.
11. This regulation does not provide a new fee or increase an existing fee.

ITEM #10: Noticing Language for a Deposition: Kevin Diamond presented the proposed language to notice a deposition. Current language used by most attorneys is antiquated and needs to be updated to provide clarity and uniformity. It was discussed to remove the words “who is also” from the proposal. The Board will reach out to former Board member Lisa McGrane for assistance to disseminate the proposed language. No further comments.
