Commission General Regulation 524**

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 502.

1. A clear and concise explanation of the need for the adopted regulation:

The regulation is necessary to provide additional convenience to the Department's customers, resolve uncertainty generated by existing regulatory language and existing or proposed hunt application structures, and add to customer retention by reducing the need to transfer and potentially loose bonus points issued in junior hunt applications. This regulation will improve customer service and satisfaction, particularly for junior hunters and their parents or guardians.

Public comment was solicited during both the regulation workshop of the Nevada Board of Wildlife Commissioners (NBWC) in January 2025 and the adoption hearing in March 2025. There was no public comment.
