## **Informational Statement of Adopted Regulation as Required by Administrative Procedures Act NRS 233B.066**

LCB File No. R047-25

**The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 624 in compliance with NRS 233.066.**

**1. A clear and concise explanation of the need for the adopted regulation.**

NRS 624.220 authorizes the Nevada State Contractors Board (NSCB) to adopt regulations necessary to affect the classification and subclassification of contractors in a manner consistent with established usage and procedure as found in the construction business and to set limits on the field and scope of the operations of a contractor as may be necessary to protect the health, safety and general welfare of the public.

The Nevada State Contractors Board proposes changes to an existing regulation based upon the passage of SB16 from the 2025 legislative session, which amends NRS 624 to authorize the Board to refuse to issue a license to any unlicensed person who submits a bid for work valued at \$1,000 or more, including both labor and materials on jobs located within this State. Under this amendment, the Board may exercise this authority for up to one year from the date the unlawful bid was submitted. This change is necessary to enforce requirements established by SB16.

**2. A description of how public comment was solicited, a summary of public response, and an explanation how other interested persons may obtain a copy of the summary.**

The notice of workshop and notice of hearing to solicit comments on the proposed regulation was posted on the agency's website and on the Nevada Public Notice Website, State Library and Archives, Nevada's Regulation Notices website and both offices of the Nevada State Contractors Board. Additionally, the notice of workshop and hearing, and the proposed regulation were e-mailed electronically to approximately 627 individuals and organizations who have expressed interest in being kept informed of the Board's meetings, along with electronically to chambers of commerce and trade associations that are likely to be affected by the proposed

regulation. Public comment was solicited in the Notice of Workshop and Hearing which included the proposed regulation and small business impact statement.

Public comment was also solicited at the workshop held on January 16, 2026 and at the hearing held on February 6, 2026 which all took place at the office of the Board at 8400 West Sunset Road, Suite 150, Las Vegas, NV and 5390 Kietzke Lane, Suite 102, Reno, Nevada 89511.

**5. A description of how comment was solicited from affected businesses, a summary of their response, and an explanation how other interested persons may obtain a copy of the summary.**

Comments were solicited from affected businesses in the same manner as they were solicited from the public. The summary may be obtained as instructed in the response to question #2.

One comment by Eduardo Martinez of Western Public Affairs was received during the hearings public comment commending the NSCB and supporting all regulations heard this day.

**6. If the regulation was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulation without change.**

The regulation was adopted on February 25, 2026 without changing any part of the proposed regulation as no public comment was received at the workshop or hearing to change the proposed regulation and no written comments were received by the Board to change the proposed regulation.

**(a) Both adverse and beneficial effects**

This regulation is not expected to have any adverse effects. One additional benefit will be that licensed contractors will have opportunity to bid on more projects and the public will be protected by hiring licensed contractors.

**(b) Both immediate and long-term effects.**

The immediate and long-term effects of this regulation will result in benefit to existing, licensed contractors and also to the public.
