

**SMALL BUSINESS IMPACT STATEMENT AS REQUIRED BY
NRS 233B.0608/233B.0609**

- 1. A description of the manner in which comment was solicited from affected small businesses, a summary of their response and an explanation of the manner in which other interested persons may obtain a copy of the summary.**

This regulation does not affect small business. The Commission on Peace Officer Standards and Training (Commission) solicited comments to any persons by means of Noticing the Workshop, Public Comment Hearing, and regularly scheduled Commission meeting. There were no responses, including small businesses, at any meetings nor submitted in writing.

- 2. The manner in which the analysis was conducted, including the methods used to determine the impacts of the proposed regulation on small business.**

Pursuant to NRS Chapter 289, the Commission on Peace Officer Standards and Training regulates the minimum standards for the certification, decertification, selection and training of peace officers. Peace officers are employees of law enforcement agencies which are governmental entities. These law enforcement officers and agencies do not fall under the definition of "small business" set out in NRS 233B.0382 which is a "business conducted for profit which employs fewer than 150 full-time and part-time employees." This regulation is required pursuant to SB 147 which requires peace officers to be trained in effective responses to incidents involving dogs or where dogs are present. As these requirements relate only to law enforcement officers and agencies, they do not affect small businesses.

- 3. The estimated economic effect of the proposed regulation on the small businesses which it is to regulate, including, without limitation:**
 - (a) Both adverse and beneficial effects; and**
 - (b) Both direct and indirect effects.**

This regulation has no impact on small business.

- 4. A description of the methods that the agency considered to reduce the impact of the proposed regulation on small businesses and a statement regarding whether the agency actually used any of those methods.**

The Commission only regulates law enforcement and has no direct or indirect impact on small business. This regulation is for compliance with SB 147 to establish training for law enforcement in effective responses to incidents involving dogs or where dogs are present.

There is no cost to the agency. Training is available at no cost via online training.
