Legislative Review of Adopted Regulations per NRS 233B.066

Informational Statement Form for LCB File R069-25, Adopted by the Commission on Professional Standards in Education. The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 391:

1. A clear and concise explanation of the need for the adopted regulation:

The Commission on Professional Standards is tasked with adopting regulations prescribing the qualifications for licensing teachers and educational personnel and setting forth the educational requirements a person must satisfy in order to qualify for an endorsement in a field of specialization. This regulation updates provisions regarding requirements to teach art or music, to include holding an endorsement to teach such a subject pursuant to Senate Bill 400 (2025) and makes similar updates to physical education / health instruction in alignment with best practices. Outdated language regarding a license to teach physical education / health was repealed in lieu of an endorsement to teach physical education / health.

2. A description of how public comment was solicited, a summary of public response, and an explanation of how other interested people may obtain a copy of the summary.

Public comment was solicited through both the regulatory workshop and public hearing. The attached workshop agenda and notice was posted 15 days prior to the workshop; the attached public hearing agenda and notice was posted 30 days prior to the public hearing. These notices were then circulated through the Department's mailing list, forwarded by programmatic leads to subject matter experts across the State, as applicable, and posted with State Library and Archives and within the Department of Education in both Las Vegas and Carson City. A description of how members of the public could provide public comments was included in both items, and at least two periods of public comment were made available during the course of the meetings. The public response can be summarized as no testimony was provided. A copy of the summary may be obtained by contacting Amelia Thibault at acthibault@doe.nv.gov. No public comment was provided responsive to R069-25.

This regulation regulates public education and does not have authority over private industry or small businesses. No impact on small businesses and/or private industry was identified. A small business impact letter was drafted and published along with the regulatory workshop agenda and notice 15 days prior to the workshop. There is no summary as no responses were received, and minutes are available at <https://doe.nv.gov/boards-commissions-councils/commission-on-professional-standards>.

The Commission on Professional Standards adopted the proposed regulation at the public hearing held on May 20, 2026. No changes were required as engagements prior to the hearing (i.e., public comment, amendments, etc.) supported a quality end product requiring no further revisions.

7. The estimated economic effect of the adopted regulation on the business which it regulates and/or on the public. These must be stated separately and, in each case, include both adverse and beneficial effects, and both immediate and long-term effects.

There will be no economic effect of the regulation on the business it regulates. There is no estimated economic effect on the public. There is no adverse or beneficial effect nor immediate or long-term effect on the business that it regulates nor the public.

There is no additional cost to the agency for enforcement of this regulation.

Notice of Hearing for the Adoption of Regulations of the Commission on Professional Standards in Education
as proposed in LCB File #R069-25

The Commission on Professional Standards in Education will hold a public hearing at **9:00 A.M. on Wednesday, May 20, 2026** via [livestream](https://www.livestream.com) and at the following locations: **Nevada Department of Education Offices at 700 East Fifth Street, Board Room, Carson City and 2080 East Flamingo Road, Room 114, Las Vegas, Nevada.** The purpose of the hearing is to receive comments from all interested persons regarding the amendment of regulations pertaining to Chapter 391.XXX, 391.111, 391.215, 391.270, 391.280, 391.281, and 391.096 of the Nevada Administrative Code (NAC) pursuant to the Nevada Revised Statute (NRS) 391.019 and Senate Bill No. 400, chapter 450, Statutes of Nevada 2025, at page 2886.

Description of the proposed regulation, or the subjects and issues involved:** The proposed regulation is relating to educational personnel; NAC Chapter 391.XXX – Employment requirements for Art, Music, Physical Education, and Physical Education & Health, NAC 391.090 – Authority conferred by elementary license, NAC 391.111 – License to teach middle school or junior high school education: Qualifications; requirements and recognized subjects for endorsement; exception, NAC 391.215 – Endorsement to teach art, NAC 391.270 – Endorsement to teach music, NAC 391.280 – Endorsement to teach physical education, NAC 391.281 – Endorsement to teach physical education and Health, and NAC 391.096 – Qualifications for elementary and middle school physical education license; authorized employment.
