Legislative Review of Adopted Regulations per NRS 233B.066

Informational Statement Form for LCB File R071-25, Adopted by the Commission on Professional Standards in Education. The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 391:

1. A clear and concise explanation of the need for the adopted regulation:

The Commission on Professional Standards is tasked with adopting regulations prescribing the qualifications for licensing teachers and educational personnel and setting forth the educational requirements a person must satisfy in order to qualify for an endorsement in a field of specialization. This regulation revises provisions regarding administrator endorsements, to include authority to issue an interim administrator endorsement in alignment with Senate Bill 81 (2025).

2. A description of how public comment was solicited, a summary of public response, and an explanation of how other interested people may obtain a copy of the summary.

Public comment was solicited through both the regulatory workshop and public hearing. The attached workshop agenda and notice was posted 15 days prior to the workshop; the attached public hearing agenda and notice was posted 30 days prior to the public hearing. These notices were then circulated through the Department's mailing list, forwarded by programmatic leads to subject matter experts across the State, as applicable, and posted with State Library and Archives and within the Department of Education in both Las Vegas and Carson City. A description of how members of the public could provide public comments was included in both items, and at least two periods of public comment were made available during the course of the meetings. The public response can be summarized support testimony alongside recommendations for implementation and administrator supports. This regulation regulates public education and does not have authority over private industry or small businesses. No impact on small businesses and/or private industry was identified. The Commission on Professional Standards adopted the proposed regulation at the public hearing held on May 20, 2026. No changes were required as engagements prior to the hearing (i.e., public comment, amendments, etc.) supported a quality end product requiring no further revisions.

The Commission on Professional Standards in Education will hold a public hearing **at 9:01 A.M. on Wednesday, May 20, 2026** via [livestream](https://www.livestream.com) and at the following locations: **Nevada Department of Education Offices at 700 East Fifth Street, Board Room, Carson City and 2080 East Flamingo Road, Room 114, Las Vegas, Nevada.** The purpose of the hearing is to receive comments from all interested persons regarding the amendment of regulations pertaining to Chapter 391.XXX, 391.170, and 391.171 of the Nevada Administrative Code (NAC) pursuant to the Nevada Revised Statute (NRS) 391.019 as amended by section 18 of Senate Bill No. 81, chapter 491, Statutes of Nevada 2025, at page 3222, and NRS 391.032

The following information is provided pursuant to the requirements of Nevada Revised Statute (NRS) 233B.0603:

- *Providing for the issuance of provisional licenses to teachers and other educational personnel before completion of all courses of study or other requirements for a license in this State.*

Description of the proposed regulation, or the subjects and issues involved: The proposed regulation is relating to educational personnel; NAC Chapter 391.XXX – Endorsements, NAC 391.170 – License or endorsement as professional administrator of school; endorsement as professional administrator of program, and NAC 391.171 – Conditional endorsement as professional administrator of school: Qualifications; authorized employment; term of validity; automatic invalidity; reinstatement; requirements to apply for unconditional endorsement. The Commission will consider a regulation relating to educational personnel; authorizing the Superintendent of Public Instruction to issue an interim endorsement as a professional administrator of a program to certain persons; revising provisions governing the issuance of a license or endorsement as a professional administrator of a school, an endorsement as a professional administrator of a program and an interim endorsement as a professional administrator of a school; and providing other matters properly relating thereto.
