To whom it may concern,

The Board sent the proposed laws to approximately 236 veterinary facilities, the Board mailing list, Board members, and the Nevada Veterinary Medical Association (NVMA) in the state via email requesting that individuals address their comments, data, views, arguments, or impact that the regulations may have in written or email form to the Board. The Board presented the proposed regulations at three separate workshops as well as a hearing.

Overall, the public comment was focused on the support for equine dentistry, but not as a regulated industry. It was stated by several individuals that the need for equine dentistry exists, and the public should have the right to choose who works on their horses. Other individuals supported regulation, but not if it was over burdensome to the individual providing services. Additionally, workshops were held at the October 13, 2016 NVMA meeting at Wild West Veterinary Conference, October 20, 2016 Board Meeting in Reno, NV, and the April 27, 2017 Board Meeting in Las Vegas, NV. The proposed were posted on the Board's website and Legislative Council Bureau's website. Lastly, the regulation hearing was held on October 19, 2017 to solicit any other concerns from the public and licensees.

Approximately 20 individuals submitted written statements to the Board office over the course of the workshops and hearing. Enclosed is a list of those that submitted written testimony. The October 13, 2016 workshop was attended by approximately 21 people of whom 15 gave testimony. The October 20, 2016 workshop was attended by 9 individuals of whom 4 gave testimony. The April 27, 2017 workshop was attended by 9 individuals of whom 6

gave testimony. Enclosed is a list of those that gave testimony as well as available contact information.

The Board solicited comment from affected businesses by sending out the proposed laws to approximately 236 veterinary facilities, the Board mailing list, Board members, and the Nevada Veterinary Medical Association in the state via email requesting that the business (Veterinary facilities) and/or the licensees address their comments, data, views, or arguments or impact that the regulations may have on their business in written or email form to the Board.

Overall the comment from small business focused on the reluctance to support equine dentistry due to public safety concerns as well as the use of non-anesthetic dentals as a safe method for sufficient dental disease prevention. #### NOTICE OF INTENT TO ACT UPON A REGULATION

Notice of Hearing for the Adoption of Regulations R073-16 of the

# **Nevada State Board of Veterinary Medical Examiners**

The Nevada State Board of Veterinary Medical Examiners will hold a public hearing at 1:00 p.m. on October 19, 2017 at the Oquendo Center, 2425 E. Oquendo Rd., Las Vegas, NV 89120. The purpose of the hearing is to receive comments from all interested persons regarding the Adoption of regulations that pertain to Chapter 638 of the Nevada Administrative Code. The following information is provided pursuant to the requirements of NRS 633B.0603:

# I: Chapter 638 of NAC is hereby amended by adding the following:

#### 1. The need and the purpose of the proposed regulation or amendment.

**Section 2**: Authorizes a veterinary licensed by the Board to order compounded drug products from a pharmacy under certain circumstances and a licensed veterinarian, veterinary technician, or veterinary technician in training to administer or dispense those compounded drug products under certain circumstances.

# 2. Either the terms or the substance of the regulations to be adopted and amended.

# III: Chapter 638 of NAC is hereby amended by adding the following:

# 1. The need and the purpose of the proposed regulation or amendment.

**Section 6:** Increases from \$50 to \$200 the fee for the issuance of a permit to operate a veterinary facility that is owned by a licensed veterinarian and increases from \$25 to \$100 the fee for the renewal of such a permit. Section 6 also specifies that a veterinary facility is considered to be owned by a license veterinarian if one or more licensed veterinarians own at least 10 percent of the ownership interest in the facility, either singly or jointly. The increase in fees serves to offset the growing cost of facility inspections due to the increasing time in which takes to do a complete inspection of a facility as well as re-inspections to ensure compliance.

#### XIII: NAC 638 is hereby amended by adding the following:

#### 1. The need and the purpose of the proposed regulation or amendment.

**Section 20 and 21:** This regulation authorizes physical therapist or chiropractor to qualify for a certificate to practice animal physical therapy or animal chiropractic, respectively, if he or she is licensed to practice his or her profession in this State and has been actively licensed to practice that profession in any state for at least 1 year.
