Informational Statement per NRS 233B.066

1. A clear and concise explanation of the need for the adopted regulation.

The regulation modifications found in LCB File No. R103-24P allow for the establishment and operation of Qualified Residential Treatment Programs (QRTP) in Nevada. The new programmatic proposed regulations are a result of the requirement for states to comply with federal requirements within the Family First Prevention Services Act of 2018 (FFPSA) specific to QRTPs. This will provide a trauma focused multidisciplinary placement option for youth in need of a certain level of care. These provisions focus on various aspects of QRTP facilities regarding admission criteria, staff training, reporting, creation and adherence to policies, delivery of trauma-informed treatment for children, case plans and discharge transitions. The regulations are necessary for Nevada to provide program requirements in Nevada Administrative Code for this new facility type/level of care.

Below is a summary of how public comment was solicited by the Division of Child and Family Services (DCFS), Nevada's Department of Human Services, and a summary of the public's response.

Description of How Public Comment was Solicited

Interested person(s) were sent copies of the proposed regulations, the notice of public workshop and the public hearing notice of intent to adopt via email, upon request, or by interest. The email list included 40 individuals.

The request for comments was solicited via email and posting on appropriate websites.

Small Business Impact Questionnaire

On December 21, 2023, pursuant to NRS 233B.0608(2)(a), DCFS sent out the small business impact questionnaire for small businesses to ten (10) foster care agency owners, who may be impacted by the changes.

On February 7, 2024, DCFS sent a second small business impact questionnaire to eleven (11) foster care facilities that may be impacted. The Division received one (1) response indicating that the proposed regulations would not have an adverse effect on their facility. The results are summarized in the attached Small Business Impact Statement dated March 6, 2024.

6. If, after consideration of public comment, the regulation was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulation without change. The statement would explain the reasons for making any changes to the regulation as proposed.

There were no requests to change the proposed regulation as drafted in LCB File No. R103-24P.

 - Adverse immediate effects: There are no anticipated immediate adverse economic effects on the public, nor the facilities that will be regulated.

- Adverse long-term effects: There are no anticipated long-term adverse economic effects on the public, nor the facilities that will be regulated.
- Beneficial immediate effects: Interested facilities and child welfare agencies will now
 have the program requirements outlined in NAC for this level of care. Separate
 regulations are needed to establish the licensing requirements for QRTPs, which is the
 responsibility of the State Board of Health to implement. Members of the public who are
 in need of this level of care, will now have this available in state to support children,
 youth and families.
- Beneficial long-term effects: The proposed regulations will allow Nevada to operate QRTP's, and child welfare agencies can access this level of care for those children who historically needed this placement type but were not available within the state. Members of the public who are in need of this level of care, will now have this available in state as a long-term option mitigating possible placement disruption for children and youth.
- 8. The estimated cost to the agency for enforcement of the proposed regulation.

There is no estimated cost to implement and enforce the QRTP programming regulations (LCB File No. R103-24P). LCB File No. R103-24P refers to QRTP programming and will be the responsibility of DCFS to enforce. There are separate QRTP licensing regulations in development, which may have an estimated cost to enforce and implement. The second regulatory provisions for QRTP licensing requirements will be promulgated by another Division within the Department of Human Services (DHS). The provisions within R103-24P do not include a licensing or enforcement fee due to these provisions only relate to program requirements of a QRTP facility.

The proposed regulations do not overlap or duplicate any federal or Nevada state regulations.
