### Does the proposed regulation(s) impose a direct and significant economic burden upon small businesses or directly restrict information, operation, or expansion of a small business?

The proposed regulation is not likely to impose a direct or significant economic burden upon small business or directly restrict formation, operation, or expansion of small businesses. The Board did not receive public comment during the workshops or hearings from any small businesses.

### Method used to determine the impact on small businesses?

Public notices of the workshop and hearings were posted at a site in each county along with the Las Vegas and Carson City offices of the Attorney General, State Library and Archives, the Clark County Health District, and mailings of said notices to interested parties including affected practitioner associations within Nevada. Notices were also posted on the website maintained by the Board. 


