A Permanent Regulation Related to Environmental Programs

Legislative Review of Adopted Permanent Regulations as Required by Administrative Procedures Act, NRS 233B.066

State Environmental Commission Permanent No: R119-24P

The Nevada State Environmental Commission (SEC) offers the following informational statement in compliance with Nevada Revised Statute (NRS) 233B.066.

1. Need for Regulation

The U.S. Environmental Protection Agency (EPA) has delegated the implementation of certain federal New Source Performance Standards (NSPS) and National Emissions Standards for Hazardous Air Pollutants (NESHAP) rules that apply in Nevada to the Nevada Division of Environmental Protection (NDEP; Division). The proposed amendments update the State's "adoption by reference" regulation, so that Nevada can request delegation for the implementation of new and revised NSPS and NESHAP rules promulgated since the last update. This will allow the regulated industry to continue to work with the State rather than the EPA.

2. A description of how public comment was solicited, a summary of public response and an explanation of how other interested persons may obtain a copy of the summary.

The NDEP held a hybrid (in-person and virtual) public workshop for R119-24P on July 31, 2024. The public was invited to participate in person in the Bryan Building at 901 South Stewart Street in Carson City, Nevada, as well as at the NDEP offices at 375 East Warm Springs Road in Las Vegas, Nevada. The workshop was held to present the substance of, and receive public comment on, the proposed regulation. Seven members of the public and regulated industry attended the workshop either in person or virtually. The proposed regulations were also distributed to the Bureau of Air Quality Planning's email distribution list.

The Legislative Counsel Bureau published its draft, R119-24P, in the Nevada Register on July 5, 2024. The Division accepted written comments on R119-24I and R119-24P for 15 days ending on July 31, 2024. The Division did not receive any verbal questions concerning R119-24I and/or R119-24P during the public workshop. A summary of the workshop, including any public comment and bureau response, is included on the NDEP website as well as the SEC website.

Adoption: 03/19/2025

The SEC held a hybrid regulatory hearing on March 19, 2025, to consider possible action on R119-24P. The SEC posted its public notice, which included a link¹ and instructions to access R119-24P and pertinent documents and information supporting the regulation, for the regulatory meeting at the State Library in Carson City, at Division offices located in both Carson City and Las Vegas, at all county libraries throughout the state, and to the SEC email distribution list. The SEC also posted the public notice at the Division of Minerals in Carson City, at the Department of Agriculture, on the LCB website, on the Division of Administration website, and on the SEC website.

The SEC also published the public notice in the Las Vegas Review Journal and Reno Gazette Journal newspapers once per week for three consecutive weeks prior to the SEC regulatory meeting.

The Commissioners unanimously adopted R119-24P without change because the public and the SEC were satisfied with the proposed regulation.

<u>Regulated Business/Industry:</u> There are no economic impacts to businesses associated with this action in the short- or long-term.

<u>Public:</u> There are no adverse or economic impacts on the public associated with this action in the short- or long-term.

<u>Enforcing Agency.</u> The regulation does not impose functions on the agency that it does not already provide, so no additional costs beyond what the agency would normally incur are expected.

Not applicable; the proposed amendments adopt federal regulations from Chapter 40 Code of Federal Regulation Parts 51, 60, 61 and 63 in order to allow the NDEP to implement them in Nevada.

9. If the regulation includes provisions which are more stringent than a federal regulation, which regulates the same activity, a summary of such provisions.

The proposed amendments do not include requirements that are more stringent than the regulations of other state or federal agencies.

10. If the regulation provides a new fee or increases an existing fee, the total annual amount the agency expects to collect and the manner in which the money will be used.

R119-24P does not provide for any new fees or increases to existing fees.
