

**LEGISLATIVE REVIEW OF ADOPTED REGULATIONS AS REQUIRED BY  
NRS 233B.066  
LCB File No. R126-17**

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 632.

**INFORMATIONAL STATEMENT**

**1. A clear and concise explanation of the need for the adopted regulation.**

This regulation is necessary to update the regulations to comply with recent statutory changes (Senate Bill 227 of the 79<sup>th</sup> Session of the Nevada Legislature (2017)).

**2. A description of how public comment was solicited, a summary of public response, and an explanation how other interested persons may obtain a copy of the summary.**

Copies of the proposed regulation, notices of workshop and notices of intent to act upon the regulation were sent by U.S. mail and email to persons who were known to have an interest in the subject of nursing as well as any persons who had specifically requested such notice. These documents were also made available at the website of the Nevada State Board of Nursing (NSBN), [www.nursingboard.state.nv.us](http://www.nursingboard.state.nv.us), mailed to all county libraries in Nevada and posted at the following locations:

A workshop was held on December 19, 2017, to receive comments on the proposed regulations. No comments were provided. On or about December 18, 2017, the Executive Director of the Nevada State Board of Nursing issued a Notice of Intent to Act Upon a Regulation.

An explanation of how an interested person may obtain a copy of the summary of public response would be to go to the Nevada State Board of Nursing's physical offices located at 5011 Meadowood Mall Way, Suite 300, Reno, Nevada, 89502, and at 4220 S. Maryland Parkway, Building B, Suite 300, Las Vegas, NV 89119 or go to the NSBN website.

3. **The number of persons who:**
  - a. **Attended each hearing:** One person attended the workshop. No persons attended the hearing.
  - b. **Testified at each hearing:** No person testified at the workshop. No person testified at the hearing.
  - c. **Submitted written comments:** There were no written comments submitted.
4. **For each person identified in subparagraphs (2) and (3) of paragraph (c), the following information if provided to the agency conducting the hearing:**

  - c. **Business address;**
  - d. **Business telephone number;**

There were no written comments submitted to the Board.

5. **A description of how comment was solicited from affected businesses, a summary of their response, and an explanation how other interested persons may obtain a copy of the summary.**

Comments were solicited from affected businesses in the same manner as they were solicited from the public. The summary may be obtained, as instructed, in the response to question #1.

6. **If the regulation was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulation without change.**

The permanent regulation was adopted on January 18, 2018, without change because there were no changes recommended at either the hearing on January 18, 2018, or at the workshop on December 19, 2017.

7. **The estimated economic effect of the regulation on the business which it is to regulate and on the public. These must be stated separately, and each case must include:**

There will be no adverse or beneficial economic effects as a result of the proposed regulation because APRNs are not businesses and the public will continue to receive good health care services from APRNs. SB227 expanded the list of persons who are authorized to evaluate a person upon the emergency admission of the person to a mental health facility or hospital to include an APRN who has obtained certain psychiatric

training and experience. This regulation sets forth the required training and experience necessary for an APRN to make such authorizations.

The immediate and long-term effect of the proposed regulation would be an increase in the number of persons who are authorized to evaluate a person upon the emergency admission of the person to a mental health facility or hospital.

**8. The estimated cost to the agency for enforcement of the adopted regulation:**

There is no additional cost to the agency for the enforcement of this regulation.

**9. A description of any regulations of other State or governmental agencies which the regulation overlaps or duplicates and a statement explaining why the duplication or overlap is necessary. If the regulation overlaps or duplicates a federal regulation, the name of the regulating federal agency.**

The Nevada State Board of Nursing is not aware of any similar regulations of other state or government agencies which the proposed regulations overlap or duplicate.

This regulation does not include provisions which are more stringent than a federal regulation which regulates the same activity.
