LEGISLATIVE REVIEW OF ADOPTED REGULATIONS AS REQUIRED BY NRS 233B.066

LCB File: R176-24

The following statement is submitted for adopted amendments to Nevada Administrative Code ("NAC") Chapter 548.

1. A clear and concise explanation of the need for the adopted regulation.

The regulation adds authority to the State Conservation Commission and Conservation District Program to award grants to eligible conservation districts in good standing for projects that enhance, protect, or conserve renewable natural resources within their boundaries.

2. A description of how public comment was solicited, a summary of public response, and an explanation of how other interested persons may obtain a copy of the summary.

A public workshop was held in-person and virtually on June 25, 2024, to solicit public comment from interested parties. There were no participants during the public workshop.

A final adoption public hearing was held on January 21, 2025. Members of the public were invited to participate in-person and virtually in accordance with the Open Meeting Law. There was no public comment during the adoption hearing.

Additionally, copies of the proposed regulations, notice of workshop, and notice of intent to act upon regulations were posted to the Commission's website, the Legislative Counsel Bureau website, and the public notice website. Notices and copies of the proposed regulations were also posted at public libraries, all locations where the Commission has an office, the Legislative Buildings, and the State Office Building in Las Vegas. The Commission also allowed the public to submit written comment, though no written comment was received.

3. The number of persons from the public who:

7 people from the public attended the public hearing on January 21, 2025.

b. Testified at each hearing:

No one testified during the public hearing on January 21, 2025.

c. Submitted to the agency written comments:

No one submitted written comment.

The State Conservation Commission and the Nevada Conservation Districts Program determined that there was no impact on small businesses, therefore comments were not solicited from small businesses.

The Commission made changes in two places to the proposed regulation. The changes are not substantial changes to the subject matter and were changed to clarify the Commission's role in approving applications under this proposed language. The changes are noted below:

Change made to Section 4 (2) (b): word changed from "determine" to "advise"

(b) Submit each application to the technical committee, if appointed pursuant to subsection 1, or to another entity with expertise in matters pertaining to renewable natural resources selected by the Commission to review the application and [determine] advise whether the project will enhance, protect or conserve natural resources in the conservation district

Change made to Section 4 (2)(c) (1): word change from "pursuant to paragraph b" to "by the Commission"

- (1) Have been determined [pursuant to paragraph (b)] by the Commission to enhance, protect or conserve natural resources in the conservation district; and
