SUMMARY—Revises provisions relating to the disposition of unspent campaign contributions. (BDR 24-843)

AN ACT relating to campaign practices; requiring certain persons who do not file declarations of candidacy, acceptances of candidacy or appear on an election ballot within a certain period to dispose of unspent contributions; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Existing law provides that a person becomes a candidate if: (1) he or she files a
2 declaration of candidacy or an acceptance of candidacy; (2) his or her name appears
3 on an official ballot at any election; or (3) he or she receives contributions in excess
4 of \$100. (NRS 294A.005) **Section 1** of this bill provides that a person who qualifies
5 as a candidate by receiving contributions in excess of \$100 must dispose of the
6 unspent contributions within 2 years after the qualifying event if the person does
7 not: (1) file a declaration or acceptance of candidacy; or (2) appear on an official
8 ballot at any election.
9 Under existing law, a former public officer may use unspent contributions in a
10 future election. (NRS 294A.160) **Section 1** provides that a former public officer
11 may not use unspent contributions in a future election unless, within 2 years after
12 the expiration of his or her term of office, the former public officer: (1) files a
13 declaration or acceptance of candidacy; or (2) appears on an official ballot at any
14 election.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 294A.160 is hereby amended to read as
2 follows:

3 294A.160 1. It is unlawful for a candidate to spend money
4 received as a campaign contribution for the candidate's personal
5 use.

6 2. Notwithstanding the provisions of NRS 294A.286, a
7 candidate or public officer may use campaign contributions to pay
8 for any legal expenses that the candidate or public officer incurs in
9 relation to a campaign or serving in public office without
10 establishing a legal defense fund. Any such candidate or public
11 officer shall report any expenditure of campaign contributions to
12 pay for legal expenses in the same manner and at the same time as
13 the report filed pursuant to NRS 294A.120, 294A.200 or 294A.360.
14 A candidate or public officer shall not use campaign contributions to
15 satisfy a civil or criminal penalty imposed by law.

16 3. Every candidate for a state, district, county, city or township
17 office at a primary, general, primary city, general city or special
18 election who is elected to that office and received contributions that
19 were not spent or committed for expenditure before the primary,
20 general, primary city, general city or special election shall dispose
21 of the money through one or any combination of the following
22 methods:

23 (a) Return the unspent money to contributors;

24 (b) Use the money in the candidate's next election or for the
25 payment of other expenses related to public office or his or her
26 campaign, regardless of whether he or she is a candidate for a
27 different office in the candidate's next election;

28 (c) Contribute the money to:

29 (1) The campaigns of other candidates for public office or for
30 the payment of debts related to their campaigns;

31 (2) A political party; or

32 (3) Any combination of persons or groups set forth in
33 subparagraphs (1) and (2);

34 (d) Donate the money to any tax-exempt nonprofit entity; or

35 (e) Donate the money to any governmental entity or fund of this
36 State or a political subdivision of this State. A candidate who
37 donates money pursuant to this paragraph may request that the
38 money be used for a specific purpose.

39 4. Every candidate for a state, district, county, city or township
40 office at a primary, general, primary city, general city or special
41 election who withdraws after filing a declaration of candidacy or an
42 acceptance of candidacy or is defeated for that office and who



1 received contributions that were not spent or committed for
2 expenditure before the primary, general, primary city, general city
3 or special election shall, not later than the 15th day of the second
4 month after the election, dispose of the money through one or any
5 combination of the following methods:

6 (a) Return the unspent money to contributors;

7 (b) Contribute the money to:

8 (1) The campaigns of other candidates for public office or for
9 the payment of debts related to their campaigns;

10 (2) A political party; or

11 (3) Any combination of persons or groups set forth in
12 subparagraphs (1) and (2);

13 (c) Donate the money to any tax-exempt nonprofit entity; or

14 (d) Donate the money to any governmental entity or fund of this
15 State or a political subdivision of this State. A candidate who
16 donates money pursuant to this paragraph may request that the
17 money be used for a specific purpose.

18 5. Every candidate for a state, district, county, city or township
19 office who withdraws after filing a declaration of candidacy or an
20 acceptance of candidacy or is defeated for that office at a primary or
21 primary city election and received a contribution from a person in
22 excess of \$5,000 shall, not later than the 15th day of the second
23 month after the election, return any money in excess of \$5,000 to
24 the contributor.

25 6. Except as otherwise provided in ~~subsection 7, every~~
26 *subsections 8 and 9, a person who qualifies as a candidate in*
27 *accordance with the definition set forth in subsection 4 of NRS*
28 *294A.005 by receiving contributions in excess of \$100 but who,*
29 *within 2 years after the qualifying event, does not:*

30 (a) *File a declaration of candidacy or an acceptance of*
31 *candidacy; or*

32 (b) *Appear on an official ballot at any election,*

33 *↪ shall, not later than the 15th day of the month after the end of*
34 *the 2-year period, dispose of all contributions that have not been*
35 *spent or committed for expenditure through one or any*
36 *combination of the methods set forth in subsection 4.*

37 7. A public officer who:

38 (a) Holds a state, district, county, city or township office;

39 (b) Does not run for reelection to that office and is not a
40 candidate for any other office; and

41 (c) Has contributions that are not spent or committed for
42 expenditure remaining from a previous election,

43 *↪ shall, not later than the 15th day of the second month after the*
44 *expiration of the public officer's term of office, dispose of those*



1 contributions in the manner provided in *paragraph (a), (c), (d) or*
2 *(e) of subsection 3.*

4 **8. Subject to the restrictions set forth in subsection 9, a public**
5 **officer who:**

6 (a) Holds a state, district, county, city or township office;

7 (b) Does not run for reelection to that office and is a candidate
8 for any other office; and

9 (c) Has contributions that are not spent or committed for
10 expenditure remaining from a previous election,

11 → may use the unspent campaign contributions in a future election.

12 Such a public officer is subject to the reporting requirements set
13 forth in NRS 294A.120, 294A.125, 294A.128, 294A.200, 294A.360
14 and 294A.362 for as long as the public officer is a candidate for any
15 office.

16 **9. If, within 2 years after the expiration of his or her term of**
17 **office, a former public officer described in subsection 8 does not:**

18 (a) **File a declaration of candidacy or an acceptance of**
19 **candidacy; or**

20 (b) **Appear on an official ballot at any election,**

21 → **the former public officer shall, not later than the 15th day of**
22 **the month after the end of the 2-year period, dispose of all**
23 **contributions that have not been spent or committed for**
24 **expenditure through one or any combination of the methods set**
25 **forth in paragraphs (a), (c), (d) and (e) of subsection 3.**

26 ~~{8.}~~ **10.** In addition to the methods for disposing of the unspent
27 money set forth in ~~{subsections 3, 4, 5 and 7,}~~ **this section,** a
28 Legislator may donate not more than \$500 of that money to the
29 Nevada Silver Haired Legislative Forum created pursuant to
30 NRS 427A.320.

31 ~~{9.}~~ **11.** Any contributions received before a candidate for a
32 state, district, county, city or township office at a primary, general,
33 primary city, general city or special election dies that were not spent
34 or committed for expenditure before the death of the candidate must
35 be disposed of in the manner provided in subsection 3.

36 ~~{10.}~~ **12.** The court shall, in addition to any penalty which may
37 be imposed pursuant to NRS 294A.420, order the candidate or
38 public officer to dispose of any remaining contributions in the
39 manner provided in this section.

40 ~~{11.}~~ **13.** As used in this section, “contributions” include any
41 interest and other income earned thereon.

42 **Sec. 2.** 1. A former public officer shall, on or before
43 September 30, 2015:

44 (a) File a declaration of candidacy or acceptance of candidacy;



1 (b) Appear on an official ballot at any election held in the State;
2 or

3 (c) Dispose of unspent contributions through one or any
4 combination of the methods set forth in paragraphs (a), (c), (d) and
5 (e) of subsection 3 of NRS 294A.160.

6 2. A former public officer is subject to the reporting
7 requirements set forth in chapter 294A of NRS for as long as the
8 former public officer has unspent contributions. The provisions of
9 this subsection apply to contributions remaining from a previous
10 election and contributions that the former public officer has received
11 since the expiration of his or her term of office.

12 3. A former public officer who violates a provision of this
13 section is subject to the same penalties and procedure as if the
14 person had violated the provisions of chapter 294A of NRS. In
15 enforcing the provisions of this section, the Secretary of State has
16 the powers prescribed in NRS 294A.410 and 294A.420.

17 4. As used in this section:

18 (a) "Contributions" include any interest and other income earned
19 thereon.

20 (b) "Former public officer" means a person who, as of
21 October 1, 2013:

22 (1) Previously held a state, district, county, city or township
23 office;

24 (2) Does not currently hold that or any other office; and

25 (3) Has contributions that are not spent or committed for
26 expenditure remaining from a previous election.
