SUMMARY—Directs the Legislative Commission to authorize the construction or installation of a memorial to Nevada firefighters on the Capitol Complex. (BDR S-1221)

AN ACT relating to firefighters; directing the Legislative Commission to authorize the construction or installation of a memorial to Nevada firefighters on the Capitol Complex; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 This bill directs the Legislative Commission to authorize the construction or
2 installation of a memorial to the firefighters of this State on the grounds of the
3 Capitol Complex. This bill also requires the Legislative Commission to select the
4 design of the memorial from three alternative designs for such a memorial
5 submitted by the Professional Firefighters of Nevada. Before submitting the
6 alternative designs, this bill requires the Professional Firefighters of Nevada to
7 consult with professional and volunteer firefighter organizations not represented by
8 the Professional Firefighters of Nevada. Finally, this bill prohibits public money
9 from being spent for the design, construction or installation of the memorial.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. The Legislative Commission shall, upon
2 compliance with the provisions of this section, permit the
3 Professional Firefighters of Nevada to construct or install a
4 memorial to the firefighters of this State. The memorial must be
5 constructed or installed at an appropriate location on the Capitol
6 Complex as determined by the Legislative Commission.
7 2. The Professional Firefighters of Nevada shall submit to the
8 Legislative Commission three alternative designs for the memorial.
9 The Legislative Commission shall review the designs and select the
10 one it considers most appropriate.
11 3. Before submitting the alternative designs to the Legislative
12 Commission pursuant to subsection 2, the Professional Firefighters
13 of Nevada shall consult with professional and volunteer firefighter
14 organizations in this State which are not represented by the
15 Professional Firefighters of Nevada.
16 4. No public money may be spent for the design, construction
17 or installation of the memorial.
18 **Sec. 2.** This act becomes effective upon passage and approval.
