ADOPTED TEMPORARY REGULATION OF THE COMMISSION ON PROFESSIONAL STANDARDS IN EDUCATION

Statutory Authority: NRS 391.019

NAC 391.095 Qualifications for License

To receive an elementary license, a person must hold a bachelor's degree from an accredited college or university and have completed:

- 1. A program of preparation for teaching in the elementary grades which is approved by the Board;
- 2. Thirty-two semester hours of courses in elementary professional education consisting of:
 - (a) Eight semester hours in supervised student teaching in kindergarten through eighth grade;
 - (b) Nine semester hours in methods of teaching elementary subjects, including, but not limited to, mathematics, science and social studies;
 - (c) Nine semester hours in the teaching of literacy or language arts; and
 - (d) Sex semester hours of professional education course work in any of the following subjects:
 - (1) Classroom management;
 - (2) English as a second language;
 - (3) Technology;
 - (4) Evaluation of pupils;
 - (5) Child development;
 - (6) Special education; or
 - (7) Social and cultural issues ; or.]
- 3. To receive a physical education elementary license, a person must complete

f[F] orty-four semester hours of courses in professional studies in physical education for kindergarten through eighth grade consisting of:

- (a) Eight semester hours in supervised student teaching or physical education for kindergarten through eighth grade;
- (b) Fifteen semester hours which includes course work in each of the following areas of study:
 - (1) Anatomical kinesiology or mechanical kinesiology, or both;
 - (2) The physiology of exercise;
 - (3) The psychological or social aspects of physical education, or both;
 - (4) Motor development; and

- (5) Testing and measuring skills and abilities in physical education; and
- (c) Twenty-one semester hours in teaching elementary physical education, including, but not limited to, teaching:
 - (1) Adapted physical education;
 - (2) Methods and techniques of teaching elementary physical education;
 - (3) Rhythmic activities for pupils in elementary grades;
 - (4) Movement experiences for pupils in preschool and primary grades;
 - (5) Movement experiences for pupils in intermediate grades; and
 - (6) Advanced first aid or an equivalent course.

A person who qualifies for [an] a physical education elementary license by complying with the requirements of [this s] Subsection 3 may teach only physical education in kindergarten through eighth grade.

The Commission on Professional Standards in Public Education adopted the regulation language with amendments at the public hearing held January 13, 2005. The reason for adopting the proposed regulation is to clean up the language. Currently the language would allow an individual with only a K-8 Elementary PE license to also qualify for a regulation elementary license. The elimination of the word "or" corrects this language.
