

**ADOPTED REGULATION OF THE COMMISSION ON
PROFESSIONAL STANDARDS IN EDUCATION**

Effective October 23, 2013

AUTHORITY: §1, NRS 391.019.

A REGULATION relating to educational personnel; revising the qualifications for an endorsement to teach in a program for gifted and talented pupils; and providing other matters properly relating thereto.

Section 1. NAC 391.394 is hereby amended to read as follows:

391.394 1. Beginning September 1, 1995, to receive an endorsement to teach in a program for gifted and talented pupils, a teacher or other educational personnel must:

- (a) Hold a license for the level of education for which the program is offered; and
- (b) Have 2 years of verified experience as a teacher in schools approved by the Department.

2. In addition to the requirements listed in subsection 1, a person who wishes to receive such an endorsement must ~~{}~~ *have completed:*

(a) ~~{Have completed a}~~ *A* program of preparation for teaching pupils who have been determined to be gifted and talented that is approved by the Board; or

(b) ~~{Except as otherwise provided in subsection 3, have completed at}~~ *At* least ~~{12}~~ *3* semester hours of credit from an accredited college or university in ~~{any}~~ *each* of the following areas of study:

- (1) ~~{Introduction to the education of gifted and talented pupils;~~
- ~~—(2)}~~ Characteristics and needs of gifted and talented pupils;

- ~~{(3) Guidance and counseling for gifted and talented pupils;~~
- ~~—(4) Administration of programs for gifted and talented pupils;~~
- ~~—(5) Special needs of gifted and talented pupils, including minorities, females, and pupils with learning disabilities;~~
- ~~—(6)} (2) Assessment of gifted and talented pupils and programs for such pupils;~~
- ~~{(7) The gifted and talented pupil in a classroom for average pupils;~~
- ~~—(8) Curriculum for gifted and talented pupils;~~
- ~~—(9)} (3) Curriculum in content areas for gifted and talented pupils; *and*~~
- ~~{(10)} (4) Methodology and strategies for teaching gifted and talented pupils . {;~~
- ~~—(11) Early childhood education for gifted and talented pupils;~~
- ~~—(12) Independent study in the education of gifted and talented pupils; or~~

**Proposed Amendments to NAC 391.394 – Endorsement to Teach in Program for Gifted
and Talented Students.**

INFORMATIONAL STATEMENT

The following statement is submitted for adopted amendments to Nevada Administrative Code 391:

1. A clear and concise explanation of the need for the adopted regulation.

The need for adopting the regulation is to language for coursework requirements for consistency and identifies focused coursework in four areas: 91) characteristics and needs of gifted and talented pupils; (2) assessment of gifted and talented pupils and program for such pupils; (3) curriculum in content areas for gifted and talented pupils; and (4) methodology and strategies for teaching gifted and talented pupils

2. Description of how public comment was solicited, a summary of public response, and explanation of how other interested persons may obtain a copy of the summary.

Notice of Workshop to Solicit Comments on Proposed Regulations was sent to approximately 200 individuals and educational organizations. A workshop was held on September 12, 2013; with public comment.

The Notice of Intent to Act Upon a Regulation for public hearing and adoption was sent to approximately 200 individuals and educational organization. A public hearing was conducted on October 17, 2013 to provide the opportunity for comments by affected parties and the public. There was no public comment. The Commission on Professional Standards in Education adopted the proposed regulation.

Comments were solicited through the workshop notice of August 5, 2013, and a public hearing notice of September 9, 2013. At the September 12, 2013 Workshop to Solicit Comments, there was public comments to the proposed regulation. At the October 17, 2013 public hearing there was no public comment to the proposed regulation.

The Commission on Professional Standards in Education adopted the proposed regulation language at the public hearing held October 17, 2013. The comments received were in support of the proposed regulation and the proposed regulation was adopted without further amendments.
