SB 479 is amended as follows:

Sec. 4. Subsection 1.[b] Line 21 change the word {may} to[ must] after the words The Board.

Sec. 4. Subsection 2. Line 28 change the word {may} to [ must ] after the words The Board.

Sec. 4. Subsection 4. **Remove all language** and replace with the language in Subsection 5.[a] and [b] [Subsection 5. is removed]

Sec.5. Remove current Language and replace with. [Any disputes arising out of Sec 4 Between an Opt Out Group and the Public Employees Benefits Program is subject to judicial review]

New Sec.6. Add Language currently in Sec. 5.
