The withholding of this exculpatory evidence resulted in Klein's claim being dismissed with leaving unanswered questions as to whether or not Klein and Brown will be charged in the future for stealing an elderly inmate Fred Huston's money. NDOC employees continued to punish Klein and Brown even though they had been exonerated by the Attorney General's Office.
