AGENDA ITEM I—CALL TO ORDER AND OPENING REMARKS

President Yacenda called the meeting to order. He welcomed members of the public.

President Yacenda reflected on the importance of the Forum's bill draft request. He indicated the Forum members are addressing the Medicaid reimbursement policy, thereby standing in the gap for Nevada's seniors.

AGENDA ITEM II—PUBLIC COMMENT

President Yacenda called for public comment. No testimony was offered.

AGENDA ITEM III—APPROVAL OF MINUTES OF THE MEETING HELD ON JUNE 21, 2016, IN LAS VEGAS, NEVADA

President Yacenda presented the minutes of the June 21, 2016, meeting for review and approval.

MOTION: Verlia Davis Hoggard made a motion to approve the minutes of the June 21, 2016, meeting held in Las Vegas, Nevada. The motion was seconded by Russ Schoenbeck and passed unanimously.

AGENDA ITEM IV—DISCUSSION AND APPROVAL OF TREASURER'S REPORT, WHICH INCLUDES THE LATEST AVAILABLE BUDGET REPORTS, APPROVAL OF RECENT EXPENDITURES, AND PROPOSED EXPENDITURES

Mary Shope, Coordinator, NSHLF, reviewed the budget and expenditures of the NSHLF, as of July 31, 2016. She explained the details of the Forum's allocations, listed as \$6,207, with the remaining balance of \$2,983.97 (Exhibit B).

MOTION: Rick Kuhlmey made a motion to approve the Treasurer's report and expenditures ending July 31, 2016. The motion was seconded by Verlia Davis Hoggard and passed unanimously.

AGENDA ITEM V—PRESENTATION ON NEVADA'S MEDICAID REIMBURSEMENT RATES

Howard Baron, M.D., F.A.A.P., Secretary, Nevada State Medical Association, and past president, Clark County Medical Society, presented an overview of the medical health providers' perspective of Medicaid reimbursement and its impact on the health care delivery system (Exhibit C). Although Governor Sandoval has been supportive of the Nevada Medicaid expansion program, he stated third-party payers negotiate lower Medicaid reimbursement rates. Similarly, Dr. Baron stated Nevada's reimbursement rates, on the whole, have not been

adjusted since 2002, which has resulted in many physicians choosing to limit their coverage of Medicare and Medicaid patients. Dr. Baron suggested the Forum members and members of the public advocate for timely reimbursement reviews, which are tied to appropriate reimbursement for health care providers.

AGENDA ITEM VI—PRESENTATION ON MEDICAID REIMBURSEMENT FOR COMMUNITY-BASED SERVICES

Marta Jensen, Acting Administrator, Division of Health Care Financing and Policy (DHCFP), Department of Health and Human Services (DHHS), and Jan Prentice, Chief, Reimbursement Analysis and Payment, DHCFP, DHHS, provided Medicaid reimbursement data for nursing facilities and community-based services (Exhibit D). Ms. Jensen indicated that Nevada's expanded Medicaid population has increased, of which many persons are childless adults. She indicated that reimbursement rates are reviewed on a five-year rolling basis, but unfortunately, money allocated to provide medical care is limited.

Ms. Prentice shared the history of the rate methodologies for many services.

Jennifer Frischmann, Chief, Long-Term Services and Supports, DHCFP, DHHS, stated adults and disabled younger patients are eligible for covered services.

President Yacenda reiterated the importance of timely periodic reimbursement rate reviews. He reviewed the Nevada Medicaid—Fee for Service data by age groups (Exhibit E).

Tiffany Lewis, Manager, Reimbursement Analysis and Payment, DHCFP, DHHS, explained the review process and stated she would provide the rotating schedule data.

AGENDA ITEM VII—REPORT ON THE RESOLUTIONS OF THE NEVADA DELEGATION OF THE NATIONAL SILVER HAIRED CONGRESS

Herbert E. Randall, Ed.D., President, Nevada Delegation, NSHC, Silver Senator, provided an update on the NSHC's annual session, including the top five resolutions for 2016 and the election of officers. Dr. Randall mentioned Nevada's Delegation provided three of the top five resolutions. In addition, Dr. Randall stated that Lonnie Strait, Silver Senator, Ex Officio Member, NSHC, was elected Treasurer and he was elected as immediate past Chair (Exhibit F).

AGENDA ITEM VIII—DISCUSSION AND APPROVAL OF THE NEVADA SILVER HAIRED LEGISLATIVE FORUM'S SUMMARY REPORT TO THE LEGISLATIVE COMMISSION AND THE GOVERNOR, SEPTEMBER 2016

President Yacenda presented the NSHLF's Summary Report to the Legislative Commission and the Governor, September 2016.

At President Yacenda's request, Bryan Fernley, Senior Principal Deputy Legislative Counsel, Legal Division, LCB, shared previous legislative action on Medicaid rate reviews.

In addition, Rick Kuhlmey, Member, NSHLF, requested that the Summary's language regarding prescription readers be amended to remove the mandatory funding language.

Dr. Yacenda summarized his participation with other legislative committees that assist Nevada's seniors and whose recommendations complement the Forum's purpose (Exhibit G).

Mary Shope, previously identified, shared information about the personalized legislative tracking system. In addition, she conveyed the Forum's appreciation to LCB's staff for their efforts throughout the 2015–2016 Interim.

MOTION: Rick Kuhlmey made a motion to approve the NSHLF's *Summary Report to the Legislative Commission and the Governor*, September 2016, with the amended language for prescription readers. The motion was seconded by Mary D. Roberts and passed unanimously.

AGENDA ITEM IX—STATUS REPORT ON THE NATIONAL COUNCIL OF SILVER HAIRED LEGISLATORS (NCSHL)

Verlia Davis Hoggard, Nevada Delegate, NCSHL, reported on the NCSHL's annual convention. She indicated that NCSHL has an identity problem, which impacts its membership. She stated the Council is addressing this concern.

In addition, Ms. Davis Hoggard presented information on AAA's Nevada Yellow Dot Program, which provides medical information to first responders (Exhibit H).

AGENDA ITEM X—DISCUSSION OF FUTURE AGENDA ITEMS AND POSSIBLE MEETING DATES

Reba June Burton, Member, NSHLF, requested the Forum's handout be updated and provided to the members.

In addition, Winston Lawson, Member, NSHLF, offered to assist with speaking engagements.

AGENDA ITEM XI—PUBLIC COMMENT

President Yacenda called for public comment.

Fran Almaraz, Member, NSHLF, informed the Forum of the Nevada Alliance for Retired Americans Educational Fund's 2nd Annual Retirement Forums. She stated the Retirement Forums would feature speakers and providers of services that will be of interest to seniors, retirees, and those about to retire. The events will be held in Reno on Monday, September 26, 2016, and in Las Vegas on Friday, October 14, 2016 (Exhibit I).

AGENDA ITEM XII—ADJOURNMENT

There being no further business to come before the Forum, President Yacenda adjourned the meeting at 12:32 p.m.
