- Anyone can apply
 Restrictions on criminal history: No violent/drug related criminal activity within the last 3 years, if over 3 years old clients are subject to review by the Applicant Review Board (ARB)
- Aimed at increasing selfsufficiency.
- Vouchers are issued for clients to find rental units in Washoe County
- Client's portion of rent/utilities is based on 30% of their adjusted monthly income (ie.
 Monthly income is \$1,000, rent/utilities will be about \$333 per month)
- Units must meet affordability test before clients can move in
- Units must be inspected before RHA will start paying a portion of the rent
- RHA does not have any deposit assistance programs

Public Housing

- Units are owned by RHA and the assistance is tied to the unit (if they move out, they do not receive rental assistance)
- Anyone can apply
- Must have good rental history and have no outstanding balance owed to any utility provider
- Restrictions on criminal history: No violent/drug related criminal activity within the last 3 years, if over 3 years old clients are subject to review by the Applicant Review Board (ARB)
- Aimed at increasing self- sufficiency
- Client's portion of rent/utilities is based on 30% of their adjusted monthly income (ie. Monthly income is \$1,000, rent/utilities will be about \$333 per month)

Project Based Vouchers

- Units are owned by RHA and the assistance is tied to the unit, if the client moves, they do not take the assistance with them
- Anyone can apply
- Provided w/ community partner support
- Aimed at increasing selfsufficiency
- Restrictions on criminal history: no violent/drug related criminal history within the last 3 years, if over 3 years clients are subject to approval by the Applicant Review Board (ARB)
- Vouchers are issued for clients to find rental units in Washoe County
- Client's portion of rent/utilities is based on 30% of their adjusted monthly income (ie. Monthly income is \$1,000, rent/utilities will be about \$333 per month)
