## **Board of Registered Environmental Health Specialists**

## Nevada Revised Statutes (NRS) Chapter 625A

**Board members** (NRS 625A.030)—The Board consists of five members, as follows:

- The Chief Medical Officer, or designee; and
- Four members appointed by the Governor:
  - o Two of whom must represent the general public, pursuant to statute;
  - o One of whom must be an environmental health specialist, employed by the health district of Washoe County; and
  - o One of whom must be an environmental health specialist, employed by the health district of Clark County.

#### **Powers and duties of the Board—**The Board shall:

- Maintain a register of applicants for a certificate of registration as an environmental health specialist or environmental health specialist trainee (NRS 625A.090);
- Determine the qualifications for a certificate, pursuant to statute (NRS 625A.110);
- Determine the qualifications for a trainee to engage in the practice of environmental health (NRS 625A.115);
- Administer the certification examination (NRS 625A.120);
- Issue certificates (NRS 625A.110);
- Set fees (NRS 625A.130);
- Require continuing education for renewal of a certificate (NRS 625A.150);
- Establish acts that constitute unprofessional conduct (NRS 625A.170); and
- Take various disciplinary actions, including probation, reprimand, suspension, or revocation (NRS 625A.180).

#### **Operations of the Board**—The Board:

- Elects a chair and secretary (NRS 625A.030);
- Meets at least once annually and may meet more frequently at the request of two members of the Board or upon written request from ten environmental specialists or trainees (NRS 625A.040);
- May employ attorneys, investigators, consultants, and clerical employees (NRS 625A.055);
- Files a biennial written report of its activities with the Governor (NRS 625A.070; and
- Provides for an annual audit of its fiscal records (NRS 625A.080).

### **Background**

#### **Legislation**:

- 1987—Assembly Bill 263 (Chapter 502, *Statutes of Nevada*)—Created the Board for Registration of Public Health Sanitarians; defined "sanitarian" to mean a person qualified to advocate or recommend the use of sanitary measures for the public benefit; established qualifications to be a registered sanitarian.
- 1995—Senate Bill 4 (Chapter 73, *Statutes of Nevada*)—Changed the name to Board of Registered Environmental Health Specialists and the registrant to "environmental health specialist."
- 2005—A.B. 260 (Chapter 438, *Statutes of Nevada*)—Required a person who engages in the practice of environmental health to hold a certificate of registration; created the environmental health specialist trainee certificate of registration.

#### BOARD OF REGISTERED ENVIRONMENTAL HEALTH SPECIALISTS

# NRS 625A.030 Creation; appointment, terms, qualifications and removal of appointed members; election of Chair and Secretary.

- 1. There is hereby created the Board of Registered Environmental Health Specialists, consisting of the Chief Medical Officer or his or her designated representative and four members appointed by the Governor.
  - 2. After the initial terms, each member appointed by the Governor must be appointed for a term of 3 years.
  - 3. Of the members of the Board appointed by the Governor after the initial appointments:
  - (a) Two must represent the general public. These members must not be:
    - (1) An environmental health specialist or environmental health specialist trainee; or
- (2) The spouse or the parent or child, by blood, marriage or adoption, of an environmental health specialist or environmental health specialist trainee.
- (b) Two must be environmental health specialists, one employed by the health district containing Washoe County and one employed by the health district containing Clark County.
- 4. The Governor may, after notice and hearing, remove any member of the Board for misconduct in office, incompetency, neglect of duty or other sufficient cause.
- 5. The Board shall elect from its members who are not employees of the State a Chair and a Secretary. The Chair must be elected biennially on or before July 1 of each even-numbered year. The Secretary continues in office at the pleasure of the Board.

# NRS 625A.040 Meetings: Purpose; manner of calling; quorum; majority of those present required for decision.

- 1. The Board shall hold at least one meeting annually to:
- (a) Review and evaluate applications for certificates of registration as environmental health specialists and environmental health specialist trainees.
  - (b) Conduct examinations.
  - (c) Review expenditures by the Board.
  - (d) Prepare reports.
  - (e) Transact any other business necessary to enable the Board to carry out its duties.
- 2. Special meetings of the Board may be called by the Secretary upon the written request of any two members of the Board or upon a written request signed by 10 environmental health specialists or environmental health specialist trainees, or any combination thereof.
- 3. Three members of the Board constitute a quorum to transact all business, and a majority of those present must concur on any decision.

# NRS 625A.050 Salary of Secretary and other members; per diem allowance and travel expenses of members and employees.

1. The Secretary of the Board is entitled to receive:

- (a) A salary in an amount fixed by the Board; and
- (b) A per diem allowance and travel expenses at a rate fixed by the Board, while engaged in the business of the Board. The rate must not exceed the rate provided for state officers and employees generally.
  - 2. All other members of the Board are entitled to receive:
- (a) A salary of not more than \$150 per day, as fixed by the Board, while engaged in the business of the Board; and
- (b) A per diem allowance and travel expenses at a rate fixed by the Board, while engaged in the business of the Board. The rate must not exceed the rate provided for state officers and employees generally.
- 3. While engaged in the business of the Board, each employee of the Board is entitled to receive a per diem allowance and travel expenses at a rate fixed by the Board. The rate must not exceed the rate provided for state officers and employees generally.

(Added to NRS by 1987, 1157; A 1989, 1695; 2007, 2942)

NRS 625A.055 Employment and compensation of professionals and other personnel; reimbursement of certain expenses. The Board may employ and fix the compensation to be paid to attorneys, investigators and other professional consultants and clerical personnel necessary to the discharge of its duties and may reimburse those employees for any actual expenses they incur while acting on behalf of the Board. Any reimbursement paid pursuant to this section is in addition to any per diem allowance or travel expenses paid to those employees pursuant to NRS 625A.050.

#### NRS 625A.060 Deposit and use of money received by Board.

- 1. The Secretary of the Board shall receive and account for all money paid to the Board and deposit it in banks, credit unions and savings and loan associations in this state.
- 2. The compensation and expenses of the members and employees of the Board and the expenses of administering the provisions of this chapter must be paid from the fees received by the Board upon approval by the Board.

(Added to NRS by 1987, 1158; A 1989, 1696; 1999, 1529)

#### NRS 625A.070 Biennial reports: Contents; distribution of copies.

- 1. Before September 1 of each even-numbered year, for the biennium ending June 30 of that year, the Board shall file a written report of the activities of the Board with the Governor. The report must include the results of the annual audits of the fiscal records of the Board.
  - 2. A copy of the report must be mailed by the Board to:
  - (a) Each environmental health specialist; and
  - (b) Any other person who submits a written request to the Board for a copy.

(Added to NRS by 1987, 1158; A 1995, 90)

#### NRS 625A.080 Records of proceedings; annual audits; seal; regulations. The Board:

- 1. Shall keep a record of its proceedings.
- 2. Shall provide for an annual audit of its fiscal records.
- 3. Shall procure a seal.
- 4. May adopt such regulations as are necessary to enable it to carry out the provisions of this chapter. (Added to NRS by 1987, 1158)

NRS 625A.090 Maintenance of register of applicants and holders of certificates. The Board shall maintain a register of all:

- 1. Applicants for a certificate of registration as an environmental health specialist or environmental health specialist trainee. The register must contain:
  - (a) The name, age and place of residence of the applicant;
  - (b) The name and address of the employer of the applicant or address of the place of business of the applicant;
  - (c) The date of the application;
  - (d) The educational qualifications, practical training and experience of the applicant;
  - (e) The date on which the Board reviewed the application and the action taken;
  - (f) The number of the certificate of registration, if any, issued to the applicant; and
  - (g) Such other information as the Board considers necessary.
- 2. Persons who hold certificates of registration as environmental health specialists or environmental health specialist trainees. The register must contain:
  - (a) The name of the person;
  - (b) The name and address of the employer of the person or the address of the place of business of the person;
  - (c) The number of the certificate of registration, if any, issued to the person; and
  - (d) Such other information as the Board considers necessary.
