Pursuant to NRS 622.100, the Nevada State Board of Landscape Architecture has prepared a balance sheet for the fiscal year 2016-2017. Assembly Bill 328 raised the revenue threshold to \$200,000, as per your July 12, 2017 letter.

Upon a review of the accounts, the following items were observed:

- 1)The fund balance at the beginning of the fiscal year was off by \$30. Due to a journal entry of the 940 FUTA monies mistakenly taken out of the Deputy Executive Director's payroll. This has been corrected.
- 2) A \$12 addition mistake in FYE 6/30/16 total expenses reported in previous year's audit.
- 3) Total adjustment was \$30.00
