#### Limitations of Date:

*Point in time system based on primary offense that is being "served" at the time when data was pulled. Offender status is designated as currently "in custody, in-house" and does not adjust to concurrent or consecutive sentences. Offender may have multiple convictions, or new convictions, that are adjudicated after original incarceration.*
