RE: Millennium and Pell Grant Values Relative to the Base Registration Fee and Other Mandatory Fees

Dear Chairwoman Joiner:

Thank you for the opportunity to present before the Committee to Conduct a Study Concerning the Cost and Affordability of the Higher Education on March 22, 2018. In regards to the materials presented by the Nevada System of Higher Education (NSHE) on the subject of college affordability in Nevada, the following additional information was requested and is included herein: 1) current values of the Millennium Scholarship for the state college and universities (in addition to the community college values previously presented), relative to the base registration fee and other mandatory fees; and 2) current value of the federal Pell Grant award for all institutions types relative to the base registration fee and other mandatory fees.

In addition to the information requested, also included here is an updated slide regarding the distribution of NSHE financial aid by source. The portion of financial aid disbursed in 2015-16 from state funding sources was 14.6 percent or \$85.7 million of the total disbursed amount of \$587.7 million.

Value of the Millennium Scholarship (2017-18)

The following table indicates the portion of base registration fees and other mandatory fees covered by the Millennium Scholarship by institution type. The analysis presented to the Committee included historical information for the community colleges only and was based solely on the base registration fee. This additional data includes the state college and universities and also includes the average mandatory fees paid by all students (assuming full-time enrollment for the year totaling 30 credits). Currently, the Millennium Scholarship will fund students up to 15

Value of the Pell Grant (2017-18)

Testimony before the Committee during the March 22, 2018, meeting, indicated that the value of the Pell Grant has eroded relative to fees paid at the universities. The following table provides the portion of the base registration fee plus other mandatory fees paid by all students covered by the maximum Pell Grant award, which is \$5,920 for a full-time student (30 credits) in academic year 2017-18. The table below indicates that the Pell award exceeds the base registration fee and other mandatory fees for a full-time student at the community colleges and state college, but only covers 78.6 percent at the universities.

NSHE Financial Aid from State Sources

The portion of financial aid disbursed in 2015-16 from state funding sources was 14.6 percent or \$85.7 million of the total disbursed amount of \$587.7 million. This information is reflected in the pie chart on Slide 5 in the financial aid overview presentation. Based on a question from the committee, we realized there was lack of clarity on this slide regarding what is comprised in that number, particularly in relationship to the last three slides in the presentation that focused on state financial aid programs. Of the \$85.7 million in the state category, \$61.5 million was reported as disbursements in formal financial aid programs, as reflected in Slides 10-12. Remaining dollars in this category were expended in a variety of areas, depending upon institution and including, but not limited to, regular student employment, graduate assistant and athletic grants-in-aid, and miscellaneous scholarships. Enclosed is a revised slide for the purpose of providing clarification. Please include the revised slide in the formal meeting record.


