- Assessed to all students enrolling in a course
 - Per credit basis
- May include
 - Associated Student Union
 - Student Activity
 - Capital Improvement
 - Other fees approved by the Board of Regents
- Approved by the Board of Regents biennially, even numbered years

Registration Fees: Guiding Principles

- Shared Responsibility
 - Tuition and fees reflect shared responsibility, benefits and needs
 - Students State Institution
- Access and Affordability
 - Ensuring all students can enroll
 - Cost of attendance
 - Financial Aid package
- Predictable Pricing
 - Predictable and managed increases
 - Quality of education not compromised, to the extent feasible
 - Once set, changes only for emergency situations or extreme circumstances

Board of Regents' Process: Biennial Review of Student Registration Fees

- Chancellor appoints System Committee
 - elected student government representatives
 - campus Presidents
 - System Administration staff
- Committee considers:
 - Charges at peer institutions in western region of U.S.
 - Inflation based on Higher Education Price Index (or similar, appropriate index)
 - Anticipated State funding
 - Institutional needs and mission
 - Other indicators, as appropriate
 - Student input
- BOR approves by June 30th of even numbered year
