SUBJECT: **Fingerprinting and Background Checks**

This memorandum responds to the questions that arose during a Sunset Subcommittee meeting regarding fingerprinting and background checks. Specifically, how are fingerprints for background checks submitted, as well as what is the cost incurred to the entity making the request?

SUMMARY

Criminal records that have originated in a criminal justice agency in Nevada are maintained by the Central Repository for Nevada Records of Criminal History. A criminal history records check can be done at a local sheriff's office or police department, but the response will only include records specific to that office or department. Consistent with agreements the Federal Bureau of Investigations (FBI) has with the states, all national fingerprint-based background checks should be submitted through the state central record repository for a state criminal history record check.

Both the FBI and states establish their own [fee structure](#) for processing fingerprint-based criminal background checks. Fingerprints can be submitted electronically to the Central Repository through [LiveScan](#). Law enforcement agencies can submit fingerprints directly, while all other agencies submit indirectly through an approved contractor. For Nevada, the only contactor approved to submit prints to the Central Repository electronically is Idemia (formerly MorphoTrust). State fees are the same whether submitting electronically or manually.

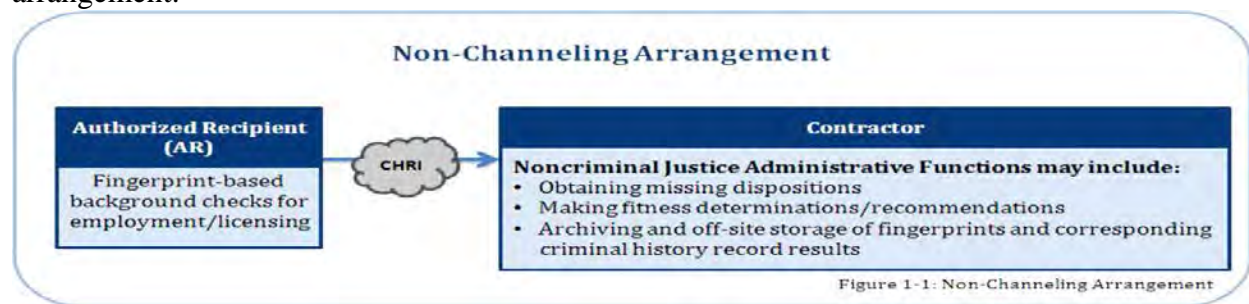
NATIONAL FINGERPRINT-BASED BACKGROUND CHECKS

The National Crime Prevention and Privacy Compact Act of 1998 established the [Compact Council](#) (Council), under the FBI, which oversees the use of criminal history record information (CHRI) for noncriminal justice purposes. This compact organized an electronic information sharing system between the federal government and states to exchange criminal history records for noncriminal justice purposes authorized by federal law, state law, and executive orders. In 1999, Senate Bill 484 (Chapter 133, *Statutes of Nevada*) ratified the National Crime Prevention and Privacy Compact, now codified in *Nevada Revised Statutes* (NRS) [179A.800](#). As of December 2014, 30 states and the federal government have ratified the Compact. States that have ratified the Compact are referred to as “party states.”

Pursuant to the Compact, any request for a criminal history record check using national indices must be submitted through the state’s criminal history repository. Only those authorized by a federal or state statute approved by the FBI may request a fingerprint-based background check from the FBI. In Nevada, criminal history records are maintained by Central Repository for Nevada Records of Criminal History (Repository), established by the Legislature as the central storage hub. Both the FBI and states establish their own [fee structure](#) for processing fingerprint-based criminal background checks for noncriminal justice purposes.

The Council has made outsourcing noncriminal justice administrative functions available and established two “Outsourcing Standards.”¹ There are two distinct outsourcing methods, “Non-Channeling” and “Channeling,” for noncriminal justice administrative functions for national criminal history records. The states’ central repository compact officer or chief administrator must grant permission before implementing a Channeling or Non-Channeling method.

Non-Channeling is when an authorized recipient (AR), a governmental or non-governmental agency authorized by federal or state statute to submit fingerprints and receive CHRI, engages with a contractor to perform noncriminal justice administrative functions. Administrative functions include, but are not limited to, obtaining missing dispositions, making fitness determinations/recommendations, or off-site storage and archiving of fingerprint submissions and corresponding criminal history record results. In this scenario, fingerprints are still submitted to the FBI through the state’s criminal history repository. Figure 1-1 depicts a Non-Channeling arrangement.

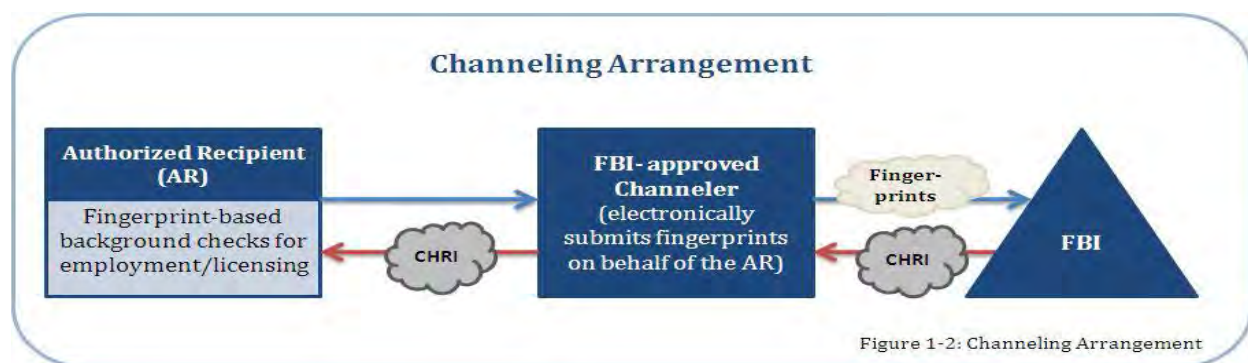

Channeling utilizes an [FBI-approved Channeler](#), which is a contractor that serves as the conduit for submitting fingerprints to the FBI and receiving the CHRI on behalf of an AR, for authorized noncriminal justice purposes. In this scenario, the Channeler performs the role of the states' central repository. Figure 1-2 illustrates the Channeling arrangement.

NEVADA FINGERPRINT-BASED BACKGROUND CHECKS

Nevada criminal history records are maintained by the Central Repository for Nevada Records of Criminal History, housed within the Department of Public Safety (DPS), Records, Communications and Compliance Division. These records have originated in a criminal justice agency in Nevada and do not include records from other states or the FBI. The Division's established [fees](#), set in accordance with statute, are used to fund the Records Bureau's operations in order to maintain and disseminate the data.

An individual may request his or her criminal history record or notice of no criminal history record from the Repository. Authorized recipients can request an individual's criminal history record if authorized by Nevada statute that the FBI has approved for submission (enclosed is a list of entities approved by the FBI). All employees or applicants must provide written authorization to their employer and/or licensing board prior to their fingerprints being taken. The DPS created a [Civil Applicant waiver](#) that fulfills all of the FBI's requirements for the applicant's informed consent.

Outsourcing is available in Nevada. According to the DPS, the Repository has contracted with one channeling contractor, Idemia. Some licensing boards, like the State Board of Nursing, have their own LiveScan machines. In this case, the Board connects to the Repository through Idemia to submit fingerprints of its applicants electronically. The [total fee](#) for prints captured electronically at a Board office is \$40. If the agency is a law enforcement agency, they have a direct connection to the Repository. If they are a governmental agency (not law-enforcement) or a licensing board with their own LiveScan machine, they connect to the Repository via the channeler, Idemia.

The DPS maintains an approved list of [businesses](#) that can take fingerprints via LiveScan and submit them to the Repository electronically via Idemia. Additionally, all [law enforcement agency](#) fingerprint sites can take fingerprints for noncriminal justice purposes.

CONCLUDING REMARKS

Those licensing boards which have authority to collect criminal history background checks also hold the authority to charge a fee to submit fingerprints. In some instances, the language authorizing a fee charge is vague as to the amount to be charged. In others, for example in the NRS for the [Contractor's Board](#) and the [Chiropractic Physician's Board](#), the language specifies, "the fee must not exceed the sum of the amounts charged by the Central Repository for Nevada Records of Criminal History and the Federal Bureau of Investigation for processing the fingerprints."
