NEVADA BOARD OF HOMEOPATHIC MEDICAL EXAMINERS

Homeopathy was officially recognized under the 1938 Food, Drug, and Cosmetic Act; the 1965 Medicare Act; and the 1987 FDA Compliance Policy Guidelines. It was considered to have great benefits when compared to conventional medicine because of generally lower medical treatment and medication costs.

Formed in 1983, the Nevada Board of Homeopathic Medical Examiners (BHME), as defined by NRS 630A, protects the public health, safety and welfare through a self-supporting program of examination, licensing and regulation of physicians practicing homeopathic and integrative alternative medicine. A supporting argument for the creation of a separate board for homeopathic practices addressed the need to recognize homeopathy as a legitimate medical profession.

Increasing numbers of patients are seeking an alternative to conventional medicine. Former Governor Kenny Guinn and Lieutenant Governor Lorraine Hunt labeled Nevada the "Health Freedom State," and Nevada became the "place to go" for patients seeking alternative, integrative and complementary care as their health care of choice. Today, BHME licensees care for many thousands of patients from Nevada, the United States and around the world.

At the March 21, 2018, Sunset Committee meeting, then Homeopathic Board President Diane Kennedy stated 70 percent of homeopathic patients come from out-of-state to receive treatments at various clinics. She indicated this patient traffic adds tourism revenues. Nine doctors provided the following financial information:

Due to the high volume of out-of-state patients (based upon estimated cost/night @\$150) and food expenditures), an estimate of the additional revenue to the state totals \$14,382,414.

There are 25 licensed homeopathic physicians, 27 advanced practitioners of homeopathy and 10 homeopathic assistants. As for expanding the number of licensees in Nevada, currently there are seven licensee candidates:

The Board did not keep a log of formal complaints when inquiries were made, as they were not considered complaints but public calls inquiring about "doctors" and if they are licensed with this Board. The Executive Director would advise the caller to check if the person was licensed or recommend that they inquire with other licensing boards.

The current Board recognizes there are internal issues which need to be immediately addressed. Committees have been established and are hard at work to correct these issues. In addition, the committees will review statutes for recommended legislative changes which will assist the Board, while ensuring continued regulation and protection of the public. A new board will be elected when all concerns have been addressed and corrected.

In response to the Chairwoman's inquiries regarding the growth of homeopathic medicine, I would like to point out that in Nevada under NRS 630A that ALL ALTERNATIVE, Complementary and Integrative medicine falls under the purview of this Board. Information is available on the internet which indicates current trends in alternative medicine support the statement, "that the entire field is growing". The Nevada Homeopathic Physician's Board is the ONLY licensing body to include full-fledged physicians to oversee the proper use of such therapies.
