#### AGENDA ITEM I—CALL TO ORDER

Chair Denis called the meeting to order.

#### AGENDA ITEM II—OPENING REMARKS

Chair Denis welcomed members, presenters, and the public to the sixth meeting of the Legislative Committee on Education. He reviewed general meeting and testimony guidelines.

### AGENDA ITEM III—PUBLIC COMMENT

Jordana McCudden, Nevada Teaching Policy Fellow, TeachPlus, introduced the TeachPlus program and emphasized the positive impact of teacher leadership.

Andy Donohue, resident, Las Vegas, Nevada, expressed support for the Nevada Promise Scholarship program and benefits of the mentoring program.

Chris Daly, Deputy Executive Director of Government Relations, Nevada State Education Association (NSEA), outlined NSEA's position on several issues.

Mike Lang, Nevada Teaching Policy Fellow, TeachPlus, discussed the benefits of the TeachPlus program and student opportunities.

Aaliyah Thomas, graduate, Canyon Springs High School & The Leadership & Law Preparatory Academy, and Eden Tesfay, senior, Southeast Career Technical Academy (SECTA), representing the Summer Business Institute, Clark County, provided information on the Institute, the civic engagement project, and the Soft Serve School Safety Summit (Agenda Item III A).

Jay Craddock, resident, Las Vegas, Nevada, encouraged the Committee to consider the consolidation of bus services and the use of public transportation.

Jesus F. Jara, Ed.D., Superintendent, Clark County School District (CCSD), stated his main goal is to have one team working together to become the "number one school district for kids."

Angie Mahzahares, teacher, Justice Myron Leavitt Middle School, CCSD, invited Committee members into her classroom to see firsthand the lack of resources and overcrowded and dilapidated conditions.

Caryne Shea, Vice President, Honoring Our Public Education (HOPE) for Nevada, expressed concern with CCSD's budget deficit and the overall state of education funding.

Amanda Morgan, Legal Director, Educate Nevada Now, powered by the Rogers Foundation, submitted written testimony on behalf of Fund Our Future Nevada regarding Nevada's school funding formula (Agenda Item III B).

Anna Slighting, Board member, HOPE for Nevada, voiced concern about CCSD's budget and the need for new revenue sources to increase the Distributive School Account.

Becki West, parent, Carson City, Nevada, spoke in support of the Nevada Educational Choice Scholarship Program (NECSP) (Agenda Item III C).

Sandy Miller, former First Lady of Nevada, and member, Fund Our Future Nevada, pointed out the positive impacts of education on society and advocated for adequate education funding leading to student success.

Alyssa Masano, parent, Las Vegas, Nevada, voiced support for the NECSP.

Maria Zamora, parent, Las Vegas, Nevada, through a translator, expressed gratitude for the NECSP and requested stability of the program.

Loretta Harper, member, National Education Association of Southern Nevada (NEA-SN), and counselor, Desert Pines High School, CCSD, conveyed her opposition to the NECSP.

Maria-Teresa Liebermann, Deputy Director, Battle Born Progress, voiced opposition to the NECSP.

Jeana Taylor, parent and member, School Organizational Team (SOT), Richard H. Bryan Elementary School, CCSD, submitted written testimony that outlined concerns with school budget cuts and the need to prioritize education funding (Agenda Item III D).

Annette Dawson Owens, parent and education advocate, Las Vegas, Nevada, communicated the need to work together to ensure all students have access to a quality education.

Denise Lovern, parent and teacher, CCSD, outlined concerns with the current budget formula, class size, and availability of educational resources.

Jana Pleggenkuhle, teacher, CCSD, and member, Clark County Education Association (CCEA), advocated for a change in the education funding formula.

Tracy Leonard, sixth grade science teacher, CCSD, explained the difficulties in teaching an overcrowded sixth grade science class. She stressed that all classes are overcrowded and it is time to adequately fund education.

Dan Price, teacher, Sunrise Mount High School, CCSD; executive board member, CCEA; and former chair, Sunrise Mount's SOT, recommended a statutory change to require training for SOT administrators and parent-members.

Denise Lasher, Government Affairs Advisor, American Federation for Children, expressed support for the NECSP.

Robert Cowles, member, NEA-SN, and member, Fund Our Future Nevada, stated the issue of inadequate education funding has resulted in large class sizes and fewer opportunities for students.

Mendel Levine, Rabbi and Executive Director, Yeshiva Day School of Las Vegas, expressed support for the NECSP.

Rebecca Dirks Garcia, parent and chair, SOT, and President, Parent Teacher Association, CCSD, outlined the need to increase public education per pupil base funding.

Andrea Cole, parent and member, SOT, CCSD, outlined her concern and negative effects of CCSD's budget cuts and the need for per pupil funding to reflect actual educational costs.

Karen Zeh, Tuition Accounts Manager, Calvary Chapel Christian School, stated that Calvary Chapel Christian School enrolled 171 NECSP recipients. She asked for the \$20 million funding to remain in effect for at least School Year 2018–2019.

Erin Selly, parent, Las Vegas, Nevada, stated her three sons have benefitted from the NECSP to attend the school of their choice. She supports this program and is hopeful for her family to be awarded scholarships for the upcoming school year.

Salomêe Levy, Nevada Youth Legislator, Senate District 5, relayed concerns from school town hall meetings on sexual harassment issues. She emphasized the need for all students to have access to an anonymous sexual harassment reporting system and group counseling offered in an after school setting. Secondly, she indicated a need for student access to free tutoring.

Don Soifer, Founder and President, Nevada Action for School Options, supports the growth of quality K through 12 schools across Nevada and the NECSP.

Comments regarding activities of the Ed W. Clark High School SOT and the impact of CCSD's budget cuts were provided by an unidentified member of the public.

Dana Martin, parent, teacher, and member SOT, Greenspun Junior High School, CCSD, on behalf of the SOT, solicited support and recognition of SOTs. She stressed the severe negative impact budget cuts have had on students, teachers, and programs.

Deborah Earl, Vice President, Power2Parent (P2P), discussed education funding revenue and a request to update the education funding model.

Charlie Melvin, Public Relations Director, P2P, called for a third-party audit of CCSD's budget.

Ed Gonzalez, resident, Las Vegas, Nevada, submitted written comments with a request for an audit of the CCSD's budget (Agenda Item III E).

Rachel Ramstetter, Administrator, Desert Torah Academy, expressed support and continuation of the NECSP.

Raymond LeBoeuf, Executive Principal, Mountain View Christian School, outlined the benefits of the NECSP. He stated that Mountain View Christian School is committed to providing opportunities to students.

Erin Phillips, P2P, shared the results of a voter poll that 75 percent of voters feel that CCSD has a transparency problem. She expressed support for an audit of the CCSD, school choice, and the NECSP.

Debbie Sarver, Principal, Mountain View Christian Elementary School, stated the school's dedication to ensure a student's success. She stated the NECSP is key to that success.

Chet Miller, member, NEA-SN, HOPE for Nevada, Fund our Future Nevada, and Badass Teachers Association, expressed opposition to the NECSP and support for the public education system.

Byron Brooks, member, SOT, Neil C. Twitchell Elementary School, CCSD, discussed the school's large budget deficit and budget cuts. He supports an audit of CCSD's budget.

Lisa Mayo-DeRiso, member, SOT, Bonanza High School, CCSD, shared her SOT experience, indicated a need for the CCSD's budget to be transparent, and expressed support for an audit.

Renisha O'Donnell, M.Ed., SOT Project Coordinator, CCEA, provided a summary of the role of CCEA within the implementation of Assembly Bill 469 (Chapter 11, *Statutes of Nevada 2017*) and an SOT year-end update (Agenda Item III F).

## AGENDA ITEM V—PRESENTATION ON THE UNIQUE EDUCATIONAL CHALLENGES TO BE ADDRESSED IN THE AFRICAN AMERICAN COMMUNITY

Yvette Williams, Chair, Clark County Black Caucus (CCBC), read into the record a letter from Roxann McCoy, President, National Association for the Advancement of Colored People, Las Vegas Branch #1111 (Agenda Item V A-1).

She presented information on African American education identifying disparities, achievement, and opportunity gaps (Agenda Item V A-2).

Ms. Williams submitted the following documents:

- IMPACT—INVO Multi-Disciplinary Program to Address Childhood Trauma (Agenda Item V A-3);
- Nevada School Advanced Placement (AP) Score Distributions Data (Agenda Item V A-4);
- AP Exams by Race and Ethnicity Overview (Agenda Item V A-5);
- The Civil Rights Project, Expanding Student Opportunities, Prime 6 Program Review, CCSD (Agenda Item V A-6);

- Preliminary Nevada Career and Technical Education (CTE) Enrollment Overview (Agenda Item V A-7);
- Economic Costs of Adverse Childhood Experiences in Alaska, by Patrick Sidmore, M.S.W., for the Alaska Mental Health Board and the Advisory Board on Alcoholism and Drug Abuse (Agenda Item V A-8); and
- A Yale Child Student Center research study brief titled, *Do Early Educators' Implicit Biases Regarding Sex and Race Relate to Behavior Expectations and Recommendations of Preschool Expulsions and Suspensions?*

Discussion ensued between Vice Chair Thompson and Ms. Williams with regards to CTE program access and outreach efforts to African American students.

# AGENDA ITEM VI—FACILITATED DISCUSSION AND NEXT STEPS RELATED TO THE NO TIME TO LOSE: HOW TO BUILD A WORLD-CLASS EDUCATION SYSTEM STATE BY STATE REPORT

Michelle Exstrom, Education Group Director, National Conference of State Legislatures (NCSL), shared systemic and complex education issues. She encouraged Nevada to take this opportunity to learn from the highest performing educational systems.

Senator Woodhouse discussed her participation and representation on the NCSL international study group, and advised the Committee the group will be meeting in Maryland to learn about that state's efforts to transform its educational system. She offered to provide a detailed report on the study group's findings at the Committee's next meeting.

There was discussion among Committee members and Ms. Exstrom regarding potential next steps related to the committee's work on the *No Time to Lose* report, including proposing related recommendations at the committee's Work Session in August, involving districts in forming future policies, and observing Maryland's work and progress with the *No Time to Lose* report.

## AGENDA ITEM VII—PRESENTATION ON THE NEVADA EDUCATIONAL CHOICE SCHOLARSHIP PROGRAM

Brett Barley, Deputy Superintendent for Student Achievement, Nevada Department of Education (NDE), introduced the NECSP.

Melissa Schroeder, Education Programs Professional, Title I Programs, Student Achievement Division, NDE, provided the *Nevada Educational Choice Scholarship Program 2017–2018 Report* (Agenda Item VII A).

Kim Dyson, Certified Public Accountant (CPA), AAA Scholarship Foundation, presented AAA Scholarship Foundation information (Agenda Item VII B-1). She highlighted program student success stories (Agenda Item VII B-2).

Valeria Gurr, Nevada State Director, Nevada School Choice Coalition, discussed recommendations on educational opportunity expansion for students (Agenda Item VII C).

Discussion ensued among Committee members and presenters on the following issues:

- Achievement data on NECSP recipients;
- NECSP recipient tracking challenges;
- NECSP recipients' ethnic group percentages;
- Tuition options for students attending private schools;
- Public school to private school student transfer rate;
- Private school student retention rates; and
- NECSP fund distribution process.

## AGENDA ITEM VIII—DISCUSSION CONCERNING THE EQUITY ALLOCATION MODEL FOR SCHOOL DISTRICT FUNDING

Steve Canavero, Ph.D., Superintendent of Public Instruction, NDE, presented information and recommendations on the Equity Allocation Model (Agenda Item VIII A-1). He submitted the report of the Equity Allocation Model Working Group, 2018 Update of the Equity Allocation Model (Agenda Item VIII A-2).

There was discussion among Committee members and Dr. Canavero to understand the equity allocation model formula and charter school accounting.

Richard W. Stokes, Superintendent, Carson City School District, testified to the negative impact of NDE's equity allocation model formula proposal on rural school districts (Agenda Item VIII B). He agreed with a phase-in process of the proposal.

Phyllys Dowd, Director of Business Services, Churchill County School District, reported on the negative impact of NDE's equity allocation model formula proposal to the Churchill County School District. She expressed support for the four-year phase-in process and the use of the 2018–2019 guarantee for per pupil allocation.

Dr. Canavero communicated the NDE's continued work on the proposal's details with the equity allocation committee.

### AGENDA ITEM IX—PRESENTATION ON THE REORGANIZATION OF THE CLARK COUNTY SCHOOL DISTRICT

Steve Canavero, previously identified, presented information on the reorganization of the CCSD (Agenda Item IX A-1) and the *Clark County School District 2018 Plan for the Implementation of Actions to Finalize Compliance with Assembly Bill 469* (Chapter 11, *Statutes of Nevada 2017*) (Agenda Item IX A-2).

Discussion ensued between Assemblywoman Benitez-Thompson and Dr. Canavero on per pupil weights, variances, and how school specialists receive payment for services.

### AGENDA ITEM X—PRESENTATION ON STUDENT ASSESSMENTS

Brett Barley, previously identified, provided introductory remarks on the student assessment system.

Peter Zutz, Administrator of Assessment, Data & Accountability Management, Student Achievement Division, NDE, made a presentation on the collection of student and enrollment information, student privacy, and assessments (Agenda Item X A).

Mr. Barley provided an overview of K through 12 state assessments given to students (Agenda Item X A).

There was discussion among Committee members and presenters regarding the following:

- Amount of time elementary students spend on state assessments;
- Status of SB 303 (Chapter 494, *Statutes of Nevada 2017*) that requires an audit of certain performance assessments in public schools; and
- Data gathering, requests, and privacy issues.

Teri White, President, Nevada Association of School Superintendents, and Superintendent, Douglas County School District, submitted a summary of responses from districts to survey question one—Does the district administer student assessments beyond those mandated by the state? If so, what are they? (Agenda Item X B).

There was further discussion between Assemblywoman Miller and Mr. Barley on the availability of results from the student-teacher ratio survey.

### AGENDA ITEM XI—DISCUSSION CONCERNING STUDENT SAFETY AND WELL-BEING

Ken Young, Captain, Operations Division, West Area, Police Services, CCSD; Anthony York, Captain, Operations Division, East Area, Police Services, CCSD; and Mike Blackeye, Lieutenant, Administrative Division, Police Services, CCSD, presented information on community

collaboration, school safety, school police training and drills, the community action team, and Safe Voice program (Agenda Item XI A-1) (Agenda Item XI A-2).

Captain Young reviewed proposed statutory language for law enforcement presence in middle schools (Agenda Item XI A-3) (Agenda Item XI A-4).

Captain York outlined a possible bill draft request for a school resource officer designation and expanded jurisdiction (Agenda Item XI A-5).

Steve Canavero, previously identified, informed the Committee that the School Safety Task Force continues to meet and will receive the recommendations from two subcommittees in July.

Christina (Christy) McGill, Director, Office for a Safe and Respectful Learning Environment, NDE, presented information on the Safe Voice program in collaboration with the Department of Public Safety (Agenda Item XI B).

Teri White, previously identified, submitted a summary of responses from districts to survey question two—In light of the school shootings that have happened recently, has your district embarked on any new school safety initiatives? (Agenda Item XI C).

Discussion ensued among Committee members and presenters regarding the following issues:

- The types of firearms confiscated and consequences;
- The types of paid and volunteer school police forces and their relationship with students;
- Social media crimes: and
- Concerns with the marketing and public knowledge of the Safe Voice program.

## AGENDA ITEM XII—PRESENTATION OF LEGISLATIVE PRIORITIES AND FOCUS ON RESTORATIVE PRACTICES

Tiffany Tyler, Ph.D., Chief Operations Officer, Nevada Partners, Inc., University of Nevada, Las Vegas, and Chief Executive Officer, Communities in Schools of Nevada, introduced My Brother's Keeper Alliance legislative priorities and focus on restorative practices (Agenda Item XII A-1) and CCSD's expulsion, suspension, and behavior referral totals for 2013 through 2017 (Agenda Item XII A-2).

Ken Young, previously identified, provided information on CCSD restorative justice practices (Agenda Item XII A-1).

Charles Sebek, Coordinator III, Equity and Diversity Education Department, Instructional Services Unit, CCSD, and member of My Brother's Keeper Alliance, continued the presentation with an overview of restorative justice practices (Agenda Item XII A-1).

Robert Tarter, Principal, Juvenile Court Schools/Clark County Detention Center, Instructional Services Unit, CCSD, and Michael Maxwell, Ed.D., Manager, Youth Development and Social Innovation, City of Las Vegas, outlined the following legislative priorities (Agenda Item XII A-1):

- Direct NDE to introduce a Nevada School Performance Framework indicator that recognizes Nevada schools for an overall reduction in exclusionary discipline, including a reduction in disproportionality. As part of this initiative, require public access to discipline data by school, subgroup, and offense in compliance with existing law;
- Fund evidence-based restorative justice practices to improve school culture, climate, safety, and student outcomes. Implement policy changes to create aligned statewide expectations and create funding streams through state grants;
- Increase state juvenile assessment center models that focus on youth assessment and assist
  youth and families in need of services by increasing funds targeted for these services in order
  to duplicate centers such as the Harbor in Clark and Washoe Counties;
- Mandate school-justice partnerships through state grant resources that incorporate restorative
  justice approaches to divert children from the juvenile justice system. Provide targeted funding
  to start or expand school-justice pilot programs with cross-agency stakeholder commitment;
- Eliminate exclusionary discipline in grades Pre K through 5;
- Strengthen AB 196 (Chapter 213, *Statutes of Nevada 2017*) to require training in cultural competency as a component of license certification and re-certification to increase awareness of implicit bias, positive social-behavioral interventions, ensure consistent student behavior management, and the equitable administration of discipline across all schools and districts; and
- Review due process safeguards used by local education agencies, particularly the responsibility to provide education services pending exclusionary discipline.

### AGENDA ITEM XIII—DISCUSSION CONCERNING THE NEVADA PROMISE SCHOLARSHIP PROGRAM

Nate Mackinnon, Vice Chancellor for Community Colleges, Nevada System of Higher Education, presented information on the Nevada Promise Scholarship Program (Agenda Item XIII).

Discussion ensued regarding funding sources and success of the mentor requirement.

# AGENDA ITEM XIV—PRESENTATION ON SCHOOL FUNDING SOLUTIONS AND THE SALARY INCENTIVE PROGRAM FOR PROFESSIONAL GROWTH FOR EDUCATIONAL PERSONNEL

John Vellardita, Executive Director, CCEA, presented information on school funding solutions and local revenue streams (Agenda Item XIV).

Brenda Pearson, Director of Professional Learning, CCEA, stated the professional growth system offers educators the opportunity to engage in high-quality professional learning aligned with professional goals, district initiatives, and school needs (Agenda Item XIV).

Discussion ensued regarding the local revenue stream concept and weighted funding system.

#### AGENDA ITEM XV—PUBLIC COMMENT

Chair Denis called for public comment.

Chris Daley, previously identified, commented on the overall inadequate funding of Nevada's schools. He reported the NSEA is participating in the SB 178 (Chapter 453, *Statutes of Nevada 2017*) funding working group.

Terri Gomez, parent, Las Vegas, Nevada, commented on the NECSP; the employment of English language teachers, and CCSD's budget.

Angie Sullivan, teacher, CCSD, voiced support for the professional growth plan and CCEA.

Tracy Leonard, teacher, CCSD, expressed support for the professional growth plan and CCEA.

Loretta Harper, previously identified, indicated support for the professional growth plan, but she is concerned that CCSD does not have the funds for this plan.

Stephen Augspurger, Executive Director, Clark County Association of School Administrators and Professional-Technical Employees, testified that any salary schedule that enhances professional growth is good for teacher and students.
