FINAL REPORT OF THE WORKING GROUP ON SCHOOL ORGANIZATIONAL TEAMS AND OTHER ISSUES RELATING TO THE REORGANIZATION OF THE CLARK COUNTY SCHOOL DISTRICT

Assembly Bill 469 (Chapter 11, Statutes of Nevada 2017)

In 2017, the Nevada Legislature enacted Assembly Bill 469, which codified regulations adopted by the State Board of Education to carry out the reorganization of each large school district (currently only Clark County School District[CCSD]). The bill mandates continued review of the implementation of the reorganization by the Advisory Committee to Monitor the Implementation of the Reorganization of Large School Districts (Section 45 of AB 469 [Chapter 11, Statutes of Nevada 2017]). During the meeting held on September 14, 2017, Senator Michael Roberson, Chair of the Advisory Committee, appointed Senator Becky Harris to form a working group to gather community input concerning the reorganization, specifically asking the group to obtain feedback and suggestions for improving the function and efficacy of school organizational teams (SOT).

Senator Harris requested the mayors of the cities of Boulder City, Henderson, Las Vegas, Mesquite, and North Las Vegas participate as members of the working group or appoint another person to participate as a representative of the city. The mayors appointed the following members:

In January 2018, Senator Harris resigned from office and Senator Denis was appointed Chair of the Working Group. The Working Group held five meetings to obtain input and potential recommendations from members of the public concerning SOTs and the reorganization generally. This document contains a compilation of recommendations approved by a majority of the members present during the Working Group's final meeting.

RECOMMENDATIONS OF THE WORKING GROUP

Reorganization Generally

1. Revise the *Nevada Revised Statutes* (NRS) to require the Superintendent of Public Instruction to appoint a compliance officer to oversee each large school district's compliance with the reorganization plan and subsequent legislation. The duties of the compliance officer should include, but not be limited to: (1) soliciting community feedback on SOTs and the reorganization more broadly on an ongoing basis; and (2) overseeing dispute resolution processes related to retaliation and reprisal involving SOT members.

School Organizational Teams Generally

2. Express support for ensuring the dispute resolution process for issues relating to retaliation and reprisal as a result of the performance of duties as a member of an SOT, developed by the State Board of Education (Legislative Counsel Bureau [LCB] File No. R036-18) can be: (1) completed as expeditiously as possible, ideally under 30 calendar days or less, and (2) also utilized by parents who participate in SOT proceedings but are not necessarily members.

School Organizational Team Membership

- 3. Express support for ensuring all SOT members undergo training at least one time, either online or in person, and encourage each large school district to maintain records regarding SOT members' completion of the training.
- 4. Revise NRS 388G.720 to remove requirements related to membership in an association or organization representing the SOT member's profession if the level of participation in the association or organization is below 50 percent at the local school precinct. The professional organization may continue to run the elections for SOT membership regardless of whether this threshold for participation is met.
- 5. Revise NRS 388G.730 to specify:
 - a. Each member of an SOT serves a two-year term;
 - b. Stagger the terms so that half of the members of an SOT will be up for re-election each year; and
 - c. If a parent member is no longer a parent of a student enrolled in the local school precinct, a vacancy will occur and filled in the same manner as the original selection, within 30 days.

School Organizational Team Roles

6. Express support for ensuring an SOT has a role in the principal selection process by allowing the SOT to provide advice or assistance regardless of the reason for the selection or placement of a principal in a school.

School Budgeting and Finance

- 7. Express support for efforts by the Superintendent of Public Instruction to ensure CCSD complies with the requirement that budgets be built using per-pupil funding rather than an allocation of staffing ratios.
- 8. Express support for the development by the Superintendent of Public Instruction of specific guidance to each large school district related to the provision of school police and whether their services are the responsibility of central services or the local school precinct.
- 9. Express support for the addition of the definition of a rural school for purposes of the reorganization of each large school district in NRS Chapter 388G to include remote schools.
- 10. Express support for budgetary and fiscal transparency for CCSD and further support the implementation of analytics and other tools to compile and publish data demonstrating how funds are collected and spent (e.g. the Denver Public Schools Budget Transparency Guidebook).
