Dear Regent Page and Chancellor Reilly:

I am writing on behalf of the Committee to Conduct a Study Concerning the Cost and Affordability of Higher Education to recommend that each Nevada System of Higher Education (NSHE) instructional institution participate in the American Association of University Professors' (AAUP's) annual Faculty Compensation Survey to provide valid comparative salary data year after year. We do not know if it is possible for your Board to adopt policies requiring NSHE institutions to participate in this survey, but we hope you will at least strongly encourage them to do so.

At the Committee's meeting on May 8, 2018, Joseph Roy, Ph.D., Senior Researcher, AAUP, provided an overview of state approaches to compensation and benefits for faculty that was helpful to the work of the Committee. However, it came to the attention of the Committee that some of NSHE's instructional institutions did not submit compensation information to the AAUP.

We believe that it is extremely important for all institutions in Nevada to participate in this data collection process so that institutions and policy makers have the most up-to-date and accurate information possible when making budget decisions. It is for this reason that, on June 4, 2018, the Committee voted to send this letter.
