**Mission:** Ensure the provision of effective supports and services to meet the needs of individuals and families, helping them lead independent, meaningful and dignified lives.

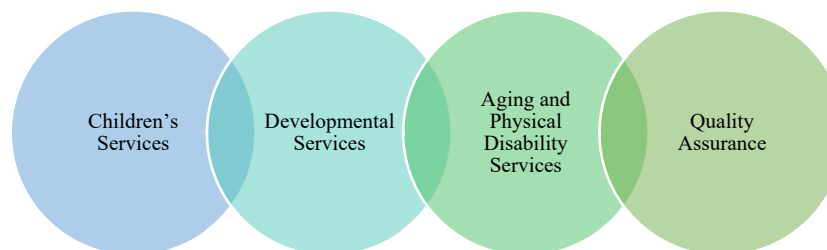

# Summary of Agency Operations



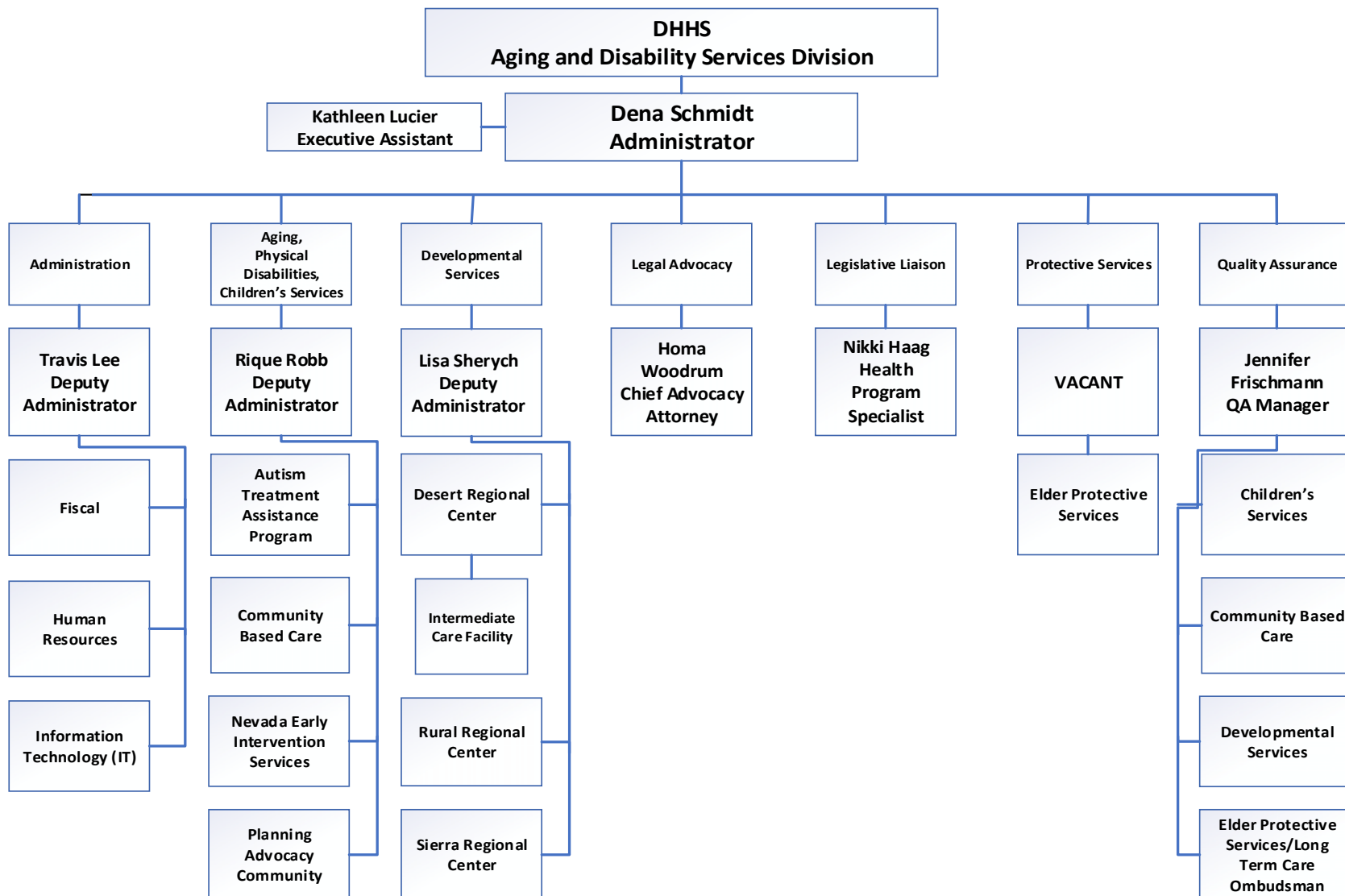
**Children's Services:** Nevada Early Intervention Services identifies infants and toddlers who are at risk for or have developmental delays or disabilities. The Autism Treatment Assistance Program provides treatment for children up to age 19 who are diagnosed with Autism Spectrum Disorder. Budgets include 3208 Early Intervention Services and 3209.

**Developmental Services:** Provides or purchases services for people with intellectual disabilities and developmental disabilities and their families with the goal of maximum independence and community inclusion. Most services are funded by Medicaid Title XIX through the Home and Community Based Waiver for the Intellectually Disabled (HCBW-ID). Budgets include 3280 Sierra Regional Center, 3279 Desert Regional Center, 3167 Rural Regional Center, and 3166 Family Preservation Program.

**Aging and Physical Disability Services:** Programs within this unit include the Assistive Technology for Independent Living, the Communication Access Program for persons who are Deaf or hard of hearing, and the Senior and Disability Rx program. The Planning, Advocacy and Community unit provide advocate services and grants management. The Community Based Care (CBC) unit which provides service to those seniors and persons with disabilities most at risk of institutionalization through the Home and Community Based Waiver for the Frail Elderly (HCBW-FE), and the Home and Community Based Waiver for the Physically Disabled (HCBW-PD). The Elder Protective Services (EPS) Program receives and investigates reports of abandonment, abuse, neglect, self neglect, exploitation, and isolation of persons aged 60 years and older. Budgets include 3266 Home and Community Based Service, 3140 Tobacco Settlement Program, and 3156 Senior and Disability Rx.

**Administration and Quality Assurance:** Provides quality assurance through provider certification, monitoring, and investigations to ensure compliance with state and federal regulations. Monitoring system improvement plans to ensure quality services. The Long-Term Care Ombudsman program advocates for residents of nursing homes, residential facilities for groups and residential care facilities. Lifespan legal rights advocacy and legal assistance development. Information technology, fiscal support, and personnel services. Budgets include 3151 Federal Programs and Administration.

- Facilitation of training of law enforcement and community partners through End Abuse in Later Life Grant partnership with Nevada Attorney General's Office.

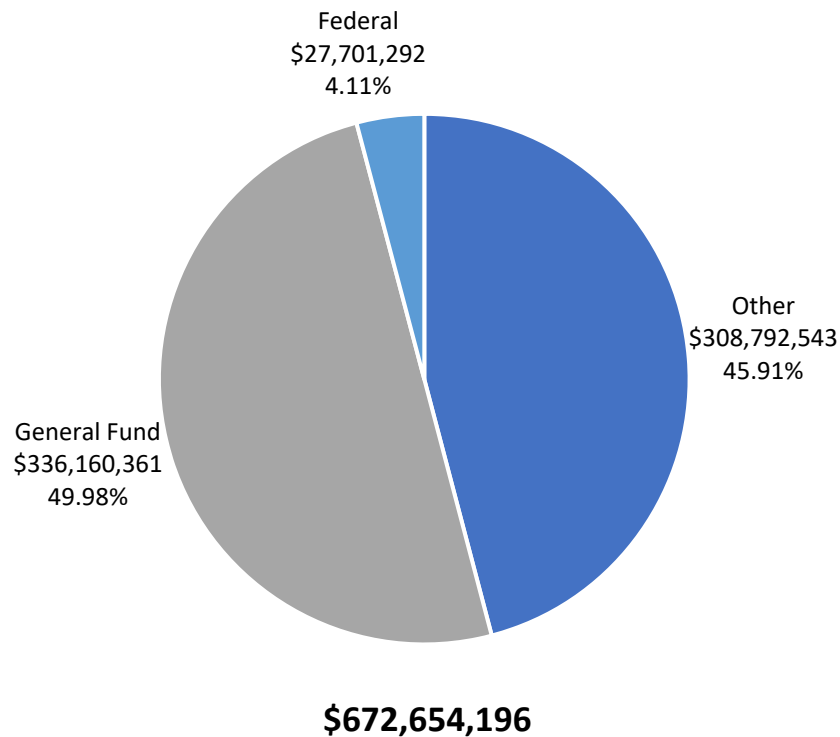

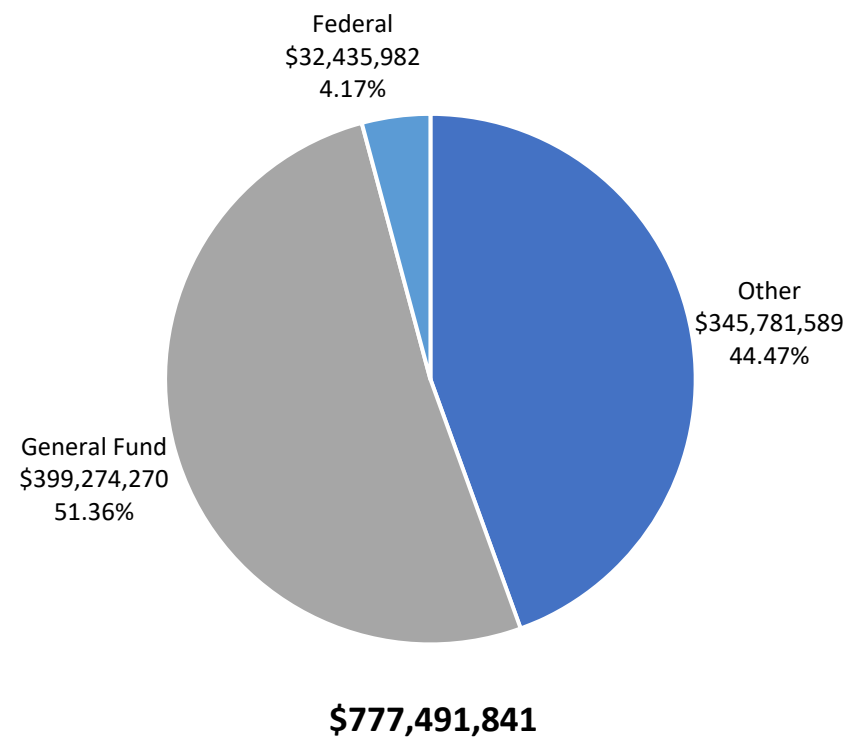

2018-2019 Biennium**



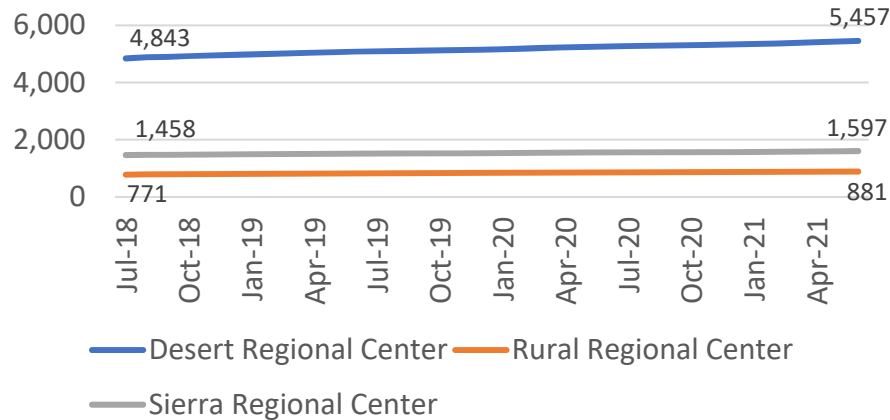

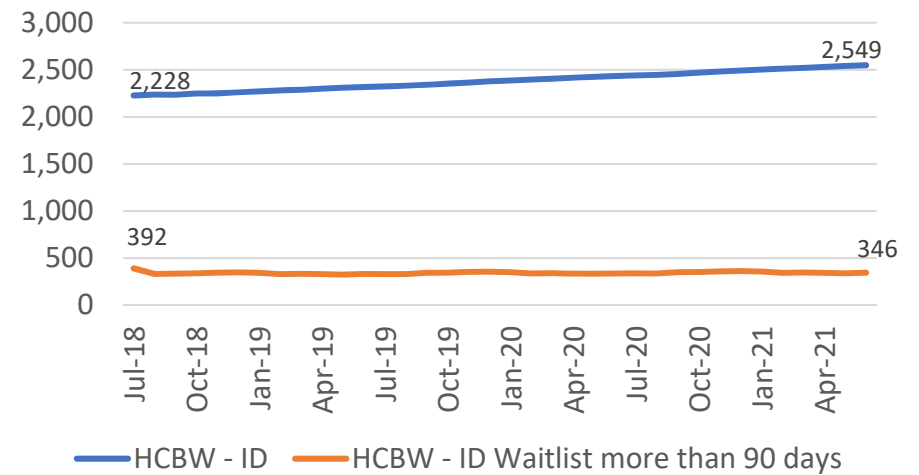

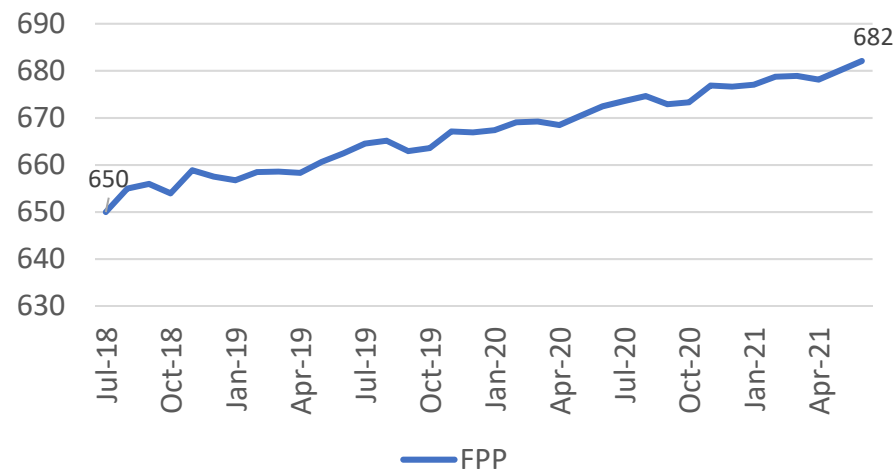
## Developmental Services Regional Centers



## HCBW – Intellectual Disabilities

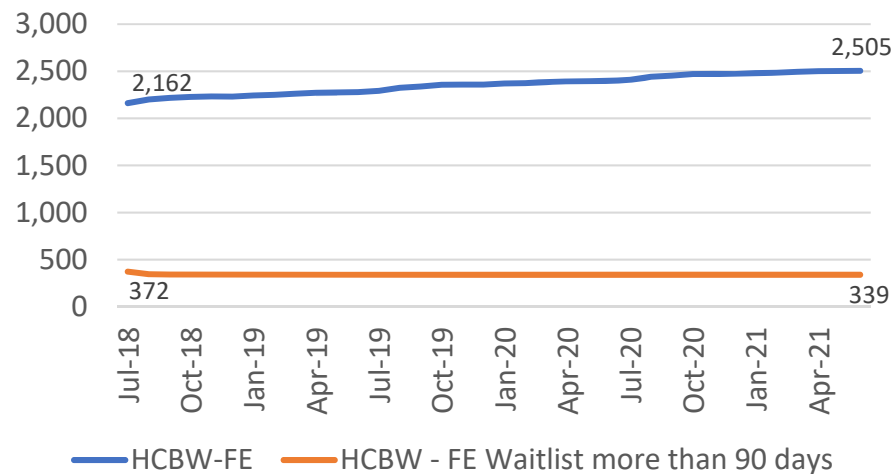


## Family Preservation Program (FPP)

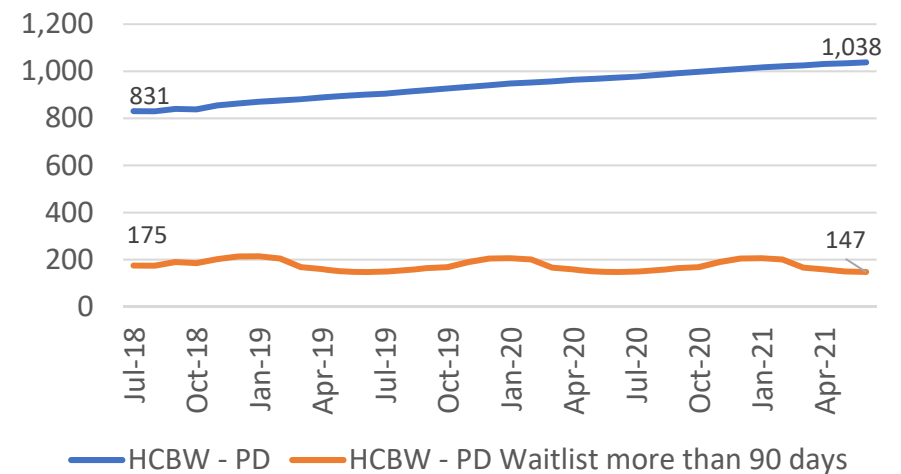

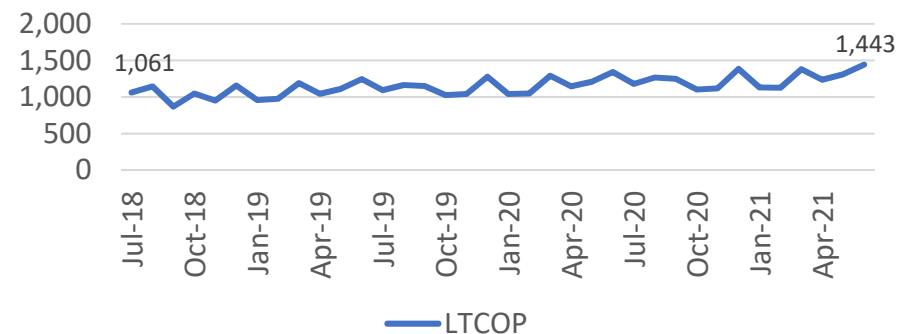
## HCBW – Frail Elderly



## HCBW – Physically Disabled

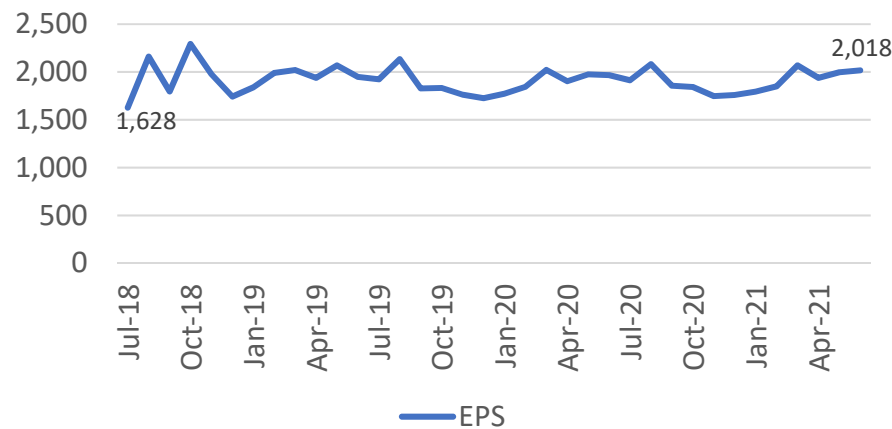


## Long Term Care Ombudsman (LTCOP)

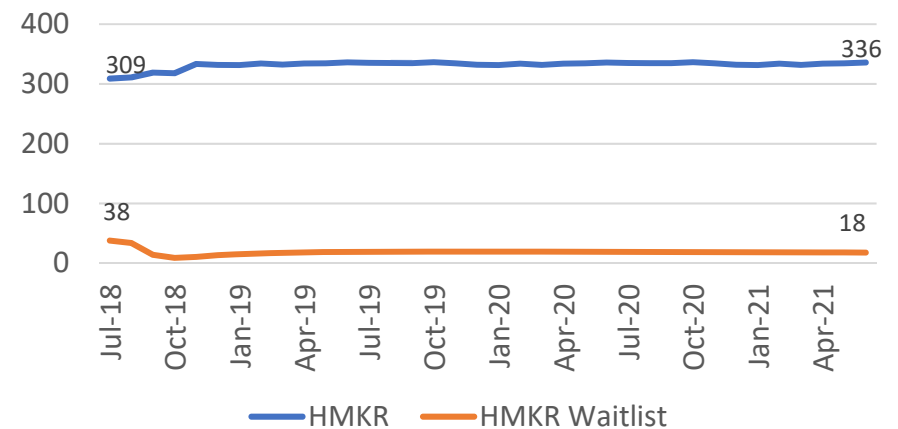

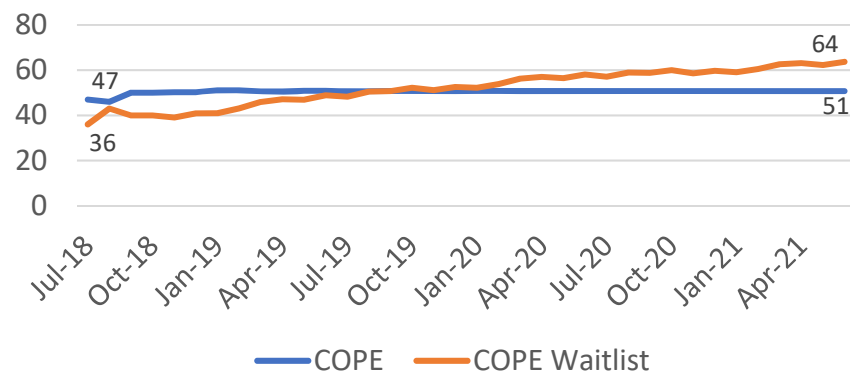
## Elder Protective Services (EPS)



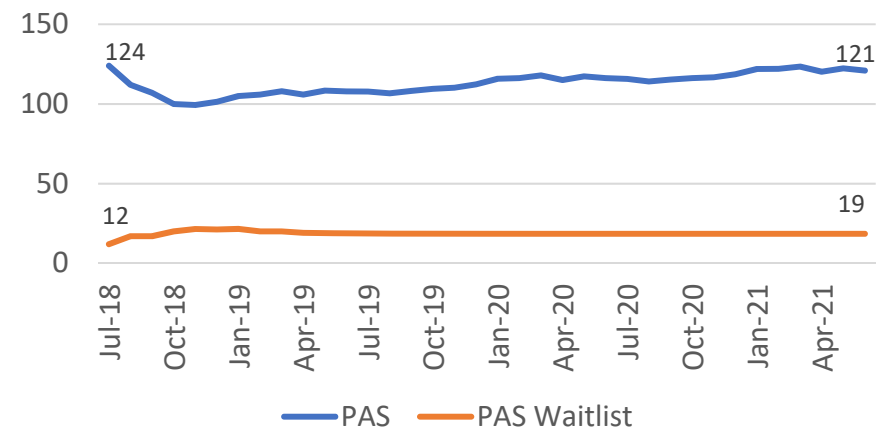
## Homemaker (HMKR)



## Community Option Programs for the Elderly (COPE)

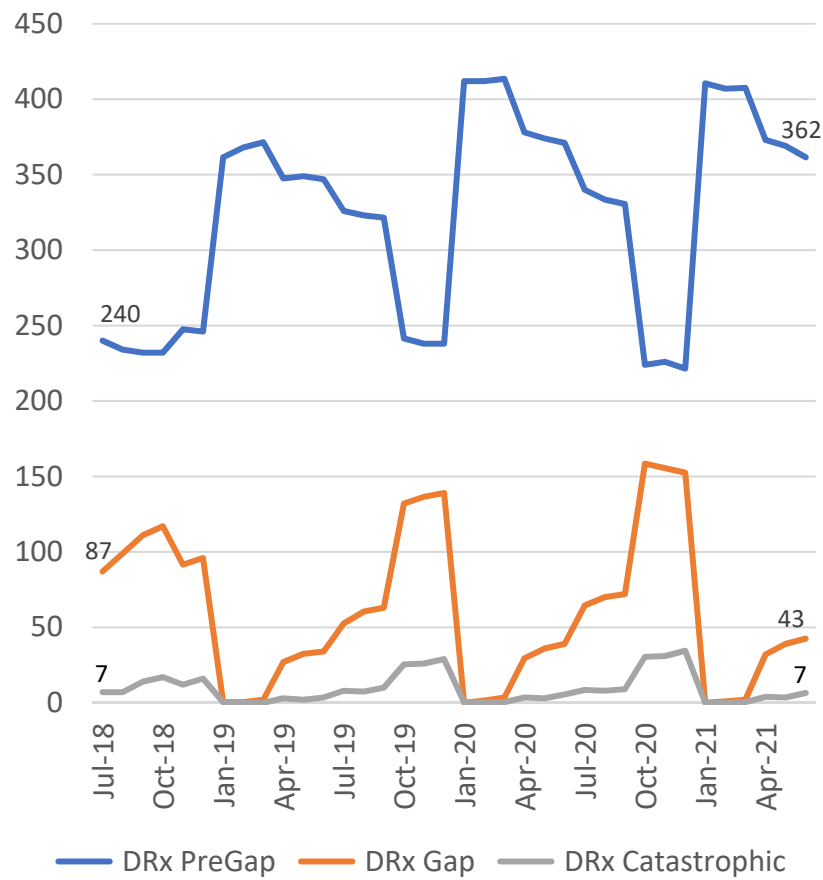


## Personal Assistance Services (PAS)

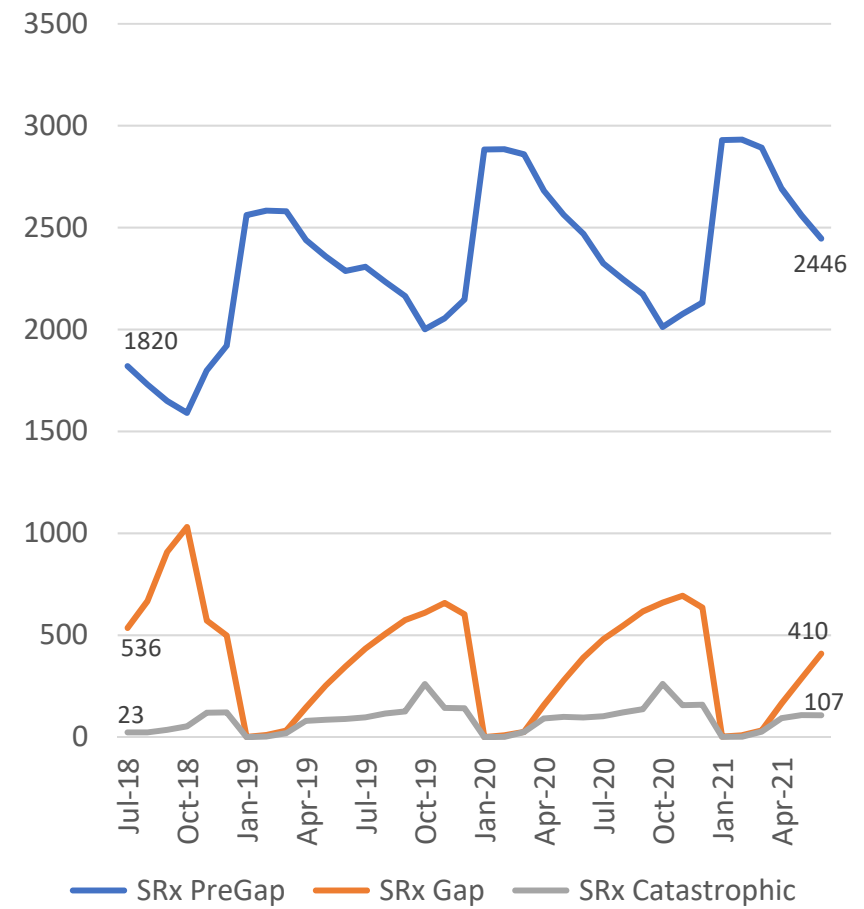


# Senior and Disability Prescription Program Caseloads

## Disability Prescription Program (DRx)

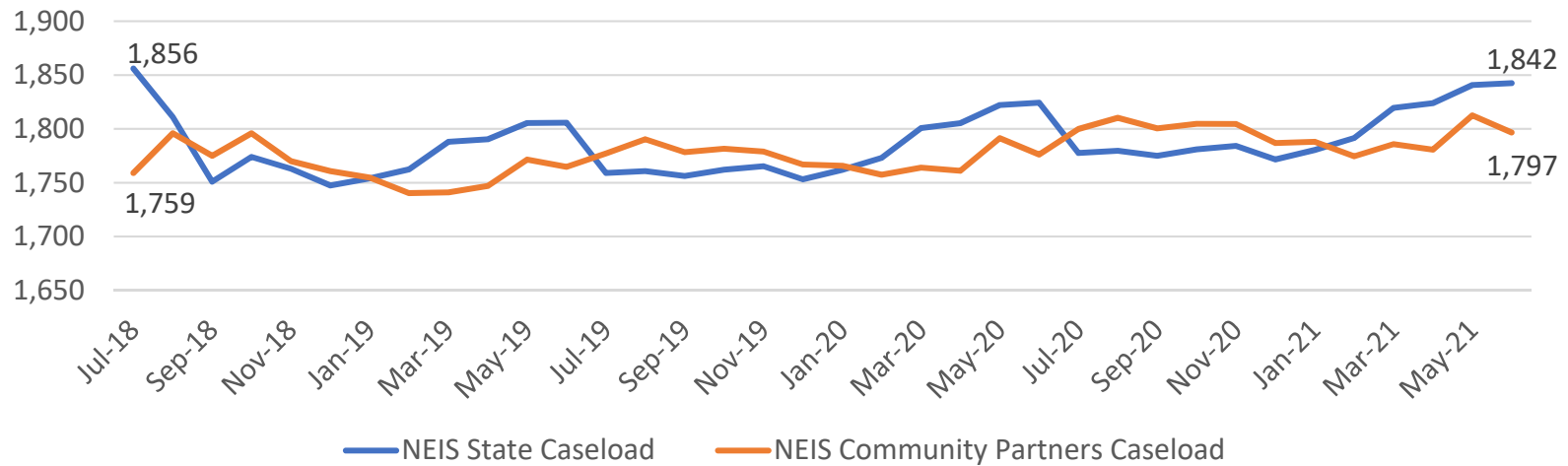


## Senior Prescription Program (SRx)

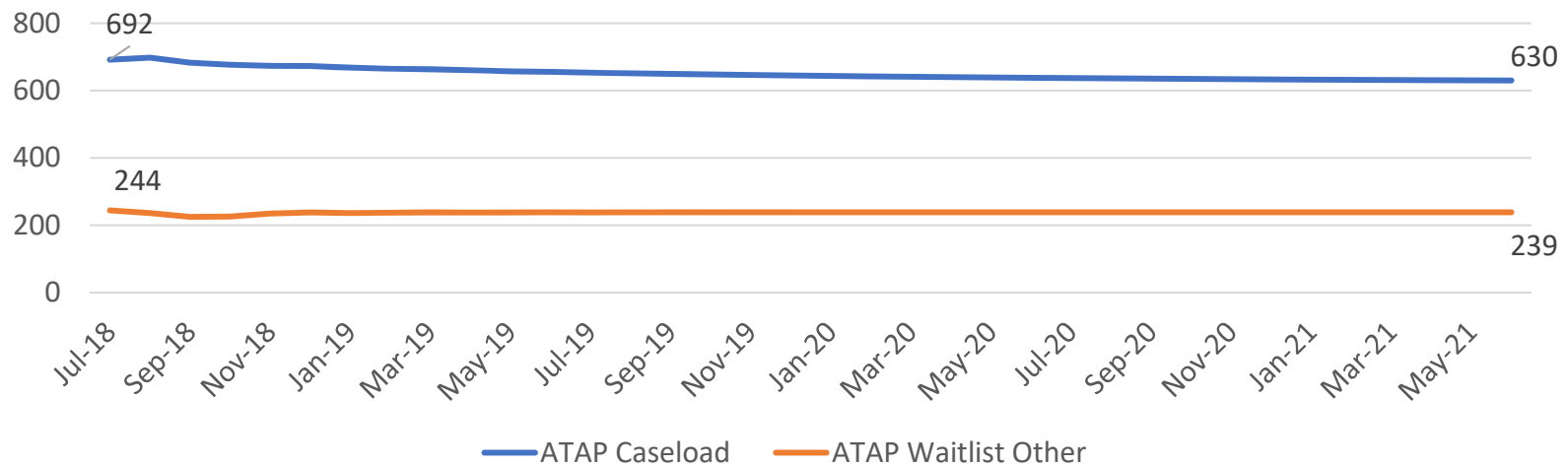

## Nevada Early Intervention Services (NEIS)



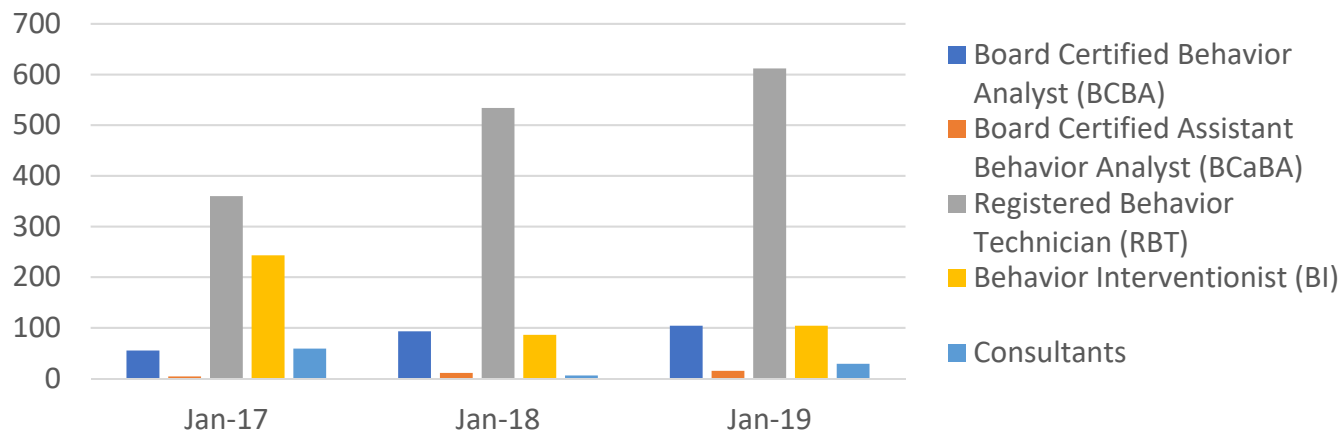

# Children's Services Program Updates

## Autism Treatment Assistance Program (ATAP)

- Community providers
  - June 2017: 29 provider companies 17 were enrolled as a Medicaid provider
  - June 2018: 46 provider companies 28 were enrolled as a Medicaid provider
  - December 2018: 49 provider companies 31 are enrolled as a Medicaid provider



## Early Intervention Services (EI)

- EI has worked with the Community Providers to obtain and maintain shared caseload distribution per the 2017 Legislative recommendations.
- The 2017 reimbursement model has been maintained in the 2019-2021 Biennium.

# Summary of Major Enhancements

## **Federal Programs and Administration**

- Increase in funding for Home Delivered Meals program for home-bound seniors.
- Rate Increases for providers in Supported Living Arrangements, Attendant Care, Personal Assistance Services (PAS), Community Options Program for the Elderly (COPE).

## **Autism Treatment Assistance Program (ATAP)**

- Increase in funding to address the waitlist for ATAP.

## **Desert Regional Center**

- Addition of 21 FTEs to support Intermediate Care Facility (ICF) operations.

## **Home and Community Based Services**

- Staffing increase aligned with support of Nevada Medicaid's request to fund waitlists for Frail Elderly/Physical Disability Waiver.

## **Adult Protective Services**

- Expansion of Protective services to include vulnerable adults 18-59.

# Bill Draft Requests

## **Policy BDRs**

- BDR 39-198 (SB 18) - Revises provisions relating to providers of Jobs and Day Training services and reduces the burden on small business.

## **Budget BDRs**

- 19A4022112 - Creates flexibility within funding to address the waitlist for home modification and assistive technology programs aimed at keeping people in their homes.
- 19A4022084 – Provide authority to ADSD to receive and investigate allegations of abuse, exploitation, neglect, isolation and abandonment of vulnerable individuals age 18-59.
