Article 3, Section 1, of the Nevada Constitution

 The powers of the Government of the State of Nevada shall be divided into three separate departments,—the Legislative, the Executive and the Judicial...

Article 6, Section 1, of the Nevada Constitution

 The judicial power of this State shall be vested in a court system, comprising a Supreme Court, a court of appeals, district courts, and justices of the peace.

Supreme Court Duties

- Administer the Nevada judicial system
- Decide, or assign to the Court of Appeals, civil and criminal cases appealed from District Courts
- Exercise extraordinary writ review writs of mandamus, certiorari, prohibition, quo warranto, and habeas corpus
- Licensure and discipline of lawyers
- Appellate review for judicial discipline

Court of Appeals Duties

- Decide civil and criminal cases appealed from District Court assigned to the court by the Supreme Court
- Exercise extraordinary writ review writs of mandamus, certiorari, prohibition, quo warranto, and habeas corpus




- AB 43
 - Increases the number of District Judges in the State by 17*
 - 15 Clark County
 - 1 Washoe County
 - 1 Elko County
 - \$2,446,248 General Fund

- AB 46
 - Provides for increases to the salaries for all Supreme Court Justices, Court of Appeals Judges, and District Court Judges beginning in January 2021
 - \$2,154,219 General Fund

*This will amended down to 10, which will bring the total General Fund down to \$1,438,961

If both bills pass as will be amended, General Fund increase would be \$3,841,900

Enhancements

- Total General Fund Increase

- Maintenance decision units (M100 & M300)
 - \$894,484 (6.9% of increase)
- Unfunded salary increases became part of the Base Budget (B000)
 - Approx. \$1.2 million (9.3% of increase)
- Salary increases as a result of a salary market survey (E815 & E849)
 - \$3,034,632 (23.6% of increase)
- Increase in General Fund support of the Supreme Court budget to spread out AA revenue to other accounts (E245)
 - \$3,143,178 (24.4% of increase)
- JDMP program support (E225 1484)
 - \$950,488 (7.4 % of increase)
- New case management system (E246)
 - \$1,290,292 (10.0% of increase)
- DUI Fee replacement (E275 1495)
 - \$1,281,432 (9.9% of increase)

Salary Market Survey

- Survey funded by General Fund appropriation from the 2017 Legislature
- Survey completed in January 2018
- Findings presented to Interim Subcommittee in June 2018
 - Salaries increased across the Court's budgets in E815 and E849
 - \$3,244,355 total cost
 - \$3,034,632 GF

- Major Survey Findings
 - Staff Attorneys 17.3% below market
 - Legal Counsel 23.4% below market
 - Court Administrator 19.7% below market
 - Admin Assistants 31.6% below market
- 109 FTE's out of 167.53 have salaries increased from 5% to 20%

Unclassified Pay Bill

- NRS 284.013 provides that Chapter 284, governing the state personnel system, does not apply to the Judicial Branch of the state government.
- NRS 284.139 and 284.140 on the composition of the unclassified service refers to the Executive department only
- The following Judicial department positions have been included in the unclassified pay bill for several sessions:
 - Chief Assistant Clerk
 - Chief Clerk
 - Chief Deputy Clerk
 - Court Administrator
 - Deputy Court Administrator (EA)
 - Supervisory Staff Attorney (EA)
 - Staff Attorney (EA)
 - Law Librarian
 - Senior Law Clerk (EA)

Administrative Assessments


NRS 176.059

- The amount collected depends on the amount of misdemeanor fine
- Recent changes to the statute
 - 2010 Special Session, the range of assessments in the fine schedule increased by \$5. Now ranges from \$30 to \$120. The \$5 increase goes to the state general fund.
- Order of Collection
 - \$2 County Treasurer for Juvenile Court
 - \$7 Municipal/Justice Court
 - \$5 to the State General Fund
 - Not less than 51% of the remainder to the Judicial Branch
 - Not more than 49% of the remainder to the Executive Branch
- Marsy's Law (Question 1) Constitutional change effective November 2018 that requires restitution to be collected first
 - Court does not yet know what impact this may have on AA revenues

Declining Reserves

- Budgets 1483 AOC and 1486 USJR have been experiencing declining reserves for the last few years. If nothing changes, those budgets would end the upcoming biennium with negative reserves. See below table for details.
- E245 in 1483, 1486, and 1494 Supreme Court propose a fix that would involve increasing the General Fund Appropriation in the Supreme Court's budget and decreasing its dependence on AA's by a commensurate amount, thus allowing 1483 and 1486 to receive more of that revenue and to maintain acceptable reserve levels.
 - According to NRS 176.059, the Supreme Court currently receives 48% of all AA's received by the Court. The proposal as currently constructed would reduce that share to 36%.
- This decision was made so as to not further increase the Court's share of AA's beyond the 60% it already receives, which would have resulted in a significant reduction to the Executive programs which depend on this fund source.

 - Cost neutral

 - To Explore Scope and Costs of Implementing Statewide Electronic Filing of Cases
 - \$95,000 Reduction to Peremptory Challenge Reserves
