#### **Legislative Summary**

 Requires the Department of Health and Human Services to conduct a feasibility study related to establishing and operating an assisted living facility in rural areas that multiple services including; respite care and adult day care.

#### **Implementation Update**

Aging and Disability Services
 (ADSD) and the Division of
 Health Care Financing and
 Policy (DHCFP) are working
 with the University of Nevada,
 Reno on a proposal to
 complete the feasibility study.



#### **Legislative Summary**

- Senate Bill aims to place pre-existing condition protections from the Affordable Care Act into Nevada law.
- Provisions related to the Office of Consumer Health Assistance(OCHA) require insurance companies to provide OCHA contact information that can be used to make more direct communication with those companies possible in the course of their advocacy for Nevadans.

- Currently assisting consumers with accessing a navigator to help obtain health care services and scheduling appointments.
- We are compiling a report of aggregated information submitted to the Office of Consumer Health Assistance.
- By December 31<sup>st</sup> of each year, health carriers will submit specific information to the Office of Consumer Health Assistance.

#### **Legislative Summary**

 Assembly Bill 228 provides permissive authority of the Administrator of the Aging and Disability Services Division to direct the referral of the State Long Term Care Ombudsman into additional settings: supported living arrangements, community- based living arrangements, adult day care, and facilities for long-term rehabilitation.

#### **Implementation Update**

 The Nevada Administrative Code revisions were submitted to the Legislative Council Bureau on December 9, 2019.



#### **Legislative Summary**

 Requires the Department to establish regulation limiting the amount a provider of health care may charge a person who has health insurance for certain medically necessary emergency services provided when the provider is out of network (a.k.a. balanced billing).

#### **Implementation Update**

- Draft regulations have been submitted to the Legislative Counsel Bureau.
- Forms for election to participate, request for arbitration and the draft regulations are available on the Office of Consumer Health Assistance Website.

#### **Legislative Summary**

The Supported Decision-Making Act

- Provides an alternative to Guardianship for individuals needing support with specific decisions without the need for full guardianship.
- Individual may select one or more supporters to assist them regarding specific decisions they may wish to make (for example, consenting to medical treatment).
- The supporter may assist with communicating that choice, informing the individual of their options, but they have no actual authority to make the decision for the individual.

#### **Implementation Update**

 Governor's Council on Developmental Disabilities has worked with a vendor to develop and conduct ongoing training and materials.



## Senate Bill 93

#### **Legislative Summary**

Revised the name and membership of the Nevada Commission for Person who are Deaf, Hard of Hearing or Speech Impaired, created a full-time paid Director position to support the Commission.

## Senate Bill 203

#### **Legislative Summary**

Creates the Account to Provide
 Programs and Services to Children Who
 Are Blind, Visually Impaired, Deaf or
 Hard of Hearing.

- ADSD reviewed all 50 states websites and material for hearing aid programs. We found 5 programs and contacted those states for feedback.
- ADSD drafted framework of policy coverage, criteria, providers, rates and funding.
- ADSD held public workshops and received good attendance and participation from clinical resources and stakeholders.
- ADSD reached to University of Nevada, Reno Audio Program through interlocal and is waiting to hear back.
- ADSD has moved to a mitigation plan and started internal meetings with our Assistive Technology/Independent Living grants and subject matter experts to explore other options.

## Senate Bill 540

#### **Legislative Summary**

 ADSD has expanded Adult Protective Services to all vulnerable person's age 18-59.

- New program became effective July 1, 2019.
- Conducting internal and external trainings.
- Launching education campaign.





# Aging and Disability Services Programs

## **Developmental Services**

Sierra Regional Center, Desert Regional Center and Rural Regional Centers provide support services for people of all ages with intellectual and/or developmental disabilities and their families through assessments, monitoring, referral and linkage to requested services through the person-centered planning process, with the goal of self-sufficiency, community inclusion and meaningful life.

- Respite; Family Preservation Program; Supported Living Arrangements;
   Jobs and Day Training Programs, Psychological and behavioral assessments and intervention; Nursing assessments and consultations;
   Nutritional counseling; and Quality assurance oversight
- Home and Community Based Waivers for Individual with Intellectual Disabilities



## Home and Community Based Waiver for the Frail Elderly and Physical Disabilities

Provides in home services to enable individuals to remain in their home and avoid placement in a long-term care facility.

 Case Management, Homemaker, Social Adult Day Care, Adult Companion, Person Emergency Response Systems, Chore, Respite, Personal Care Services

#### **State Funded Programs**

- Personal Assistance Services
- Community Options Programs for Elderly
- Homemaker



## Long Term Care Ombudsman

The Long-Term Care Ombudsman program advocate for residents of nursing homes, residential facilities for groups and homes for individual residential care facilities

Educate long-term care providers about residents' rights and elder abuse and engage in initiatives that promote quality of care and quality of life for residents of long-term care facilities



## **Adult Protective Services**

Receives and investigates reports of abuse, neglect, exploitation, abandonment and self neglect for vulnerable adults.

Provide services to vulnerable persons 18 and over to alleviate or remedy an abusive situation.

 Social services include referral of services, mental health capacity evaluations, emergency placement, emergency funds for food, rent, utilities, personal care

## Children's Services

**Nevada Early Intervention Services (NEIS)** - provides specialized supports and services for children from birth to 3 who have developmental delays or disabilities and their families in order to meet their individualized developmental and learning needs.

**Autism Treatment Assistance Program** - assists parents and caregivers with the cost of providing Autism-specific treatments to their child with Autism Spectrum Disorder

- ATAP offers various plan types designed to address each child's individual needs. Plans include:
- Comprehensive, Insurance Assistance, Extensive Basic, Targeted Basic, Therapeutic, Social Skills, and Transitional

## **Looking Forward**

### Nevada Aging & Disability Network - Creating an Age-Friendly Public Health System

- Connecting and convening multiple sector professionals that provide support services, and infrastructure to promote healthy aging.
- Coordinating existing supports and services to avoid duplication of efforts, identify gaps and increase access to services and supports.
- Collecting data to assess community health status (including inequities) and aging population needs to inform the development of interventions.
- Conducting, communicating, and disseminating research findings and best practices to support healthy aging.
- Complementing and supplementing existing supports and services, particularly in terms of integrating clinical and population health approaches.
