

#### What is the Parole Board and what do we do?

- ☐ Independent body
- □ Responsible for making decisions to either grant or deny parole.
- ☐ Returns offenders to prison whenever community safety is threatened.



#### What is Parole?

- ☐ Parole is the release from prison during which an offender continues to serve a sentence in the community.
- □ Parole is not a right. The Legislature has declared that no person should expect to be released on parole (NRS 213.10705).
- Initial parole eligibility is based on the minimum sentence imposed by the Court, less good time credits (when applicable).

#### Parole & the Judicial System

- ☐ Legal framework that empowers judges, prison officials and parole boards.
- ☐ A flexible system for punishing offenders and protecting the public.



#### Parole Hearings Types

- ☐ Discretionary Parole Hearings.
- ☐ Mandatory Parole Hearings (MPR).
- ☐ Parole Violation Hearings (PV).
- ☐ Lifetime Supervision Hearings.
- ☐ Reconsideration Hearings.




# The Nevada Parole Board FY2019 Caseload

- ☐ Between July 2018, and June 2019, the Board made 8,331 final decisions.
- □ Each decision requires at least 4 votes, and this equates to over 33,324 total votes, and approximately 4,100 cases that are reviewed per year by each Commissioner.
- ☐ When including hearings that did not result in a final parole decision, the board held over 9,400 hearings during FY 2019.



# Caseload FY16 - FY21



Actual caseload includes discretionary and mandatory parole hearings, violation hearings, continuances and hearings resulting in no action but does not include the lifetime supervision hearings, continuances and hearings which may result in no action.

## Parole Board Statutory Duties

- ☐ The Board shall adopt standards for granting or revocation of parole NRS 213.10885:
  - Risk Assessment/Crime Severity = Initial Guideline Recommendation
  - Mitigating/Aggravating Factors
  - Comprehensive Review of adopted standards
  - Report to each regular Legislative session
- ☐ Parole Board shall compile and maintain detailed information concerning all decisions regarding parole. NRS 213.10887
  - Publish information on the Internet website.



# Parole Board Statutory Duties

- ☐ Limitations on Parole Board's power to release prisoners on parole NRS 213.1099
- ☐ When a prisoner becomes eligible for parole NRS 213.120
- ☐ Aggregated Sentences NRS 213.1212
- ☐ Guidelines for Mandatory Parole NRS 213.1215:
  - Effective Through June 30, 2020
  - Effective July 1, 2020
- ☐ Geriatric Parole NRS 213.12155
- □ Release of Sex Offender Program of Lifetime Supervision NRS 213.1243

## Pardons Board Statutory Duties

- ☐ State Board of Pardons Commissioners: Members; notice of meetings to victims. NRS 213.010
- ☐ Secretary of Board: Appointment; qualifications; duties. NRS 213.017
- □ Notice of application for remission, commutation, pardon or restoration of civil rights: Contents; service. NRS 213.020
- □ Restoration of civil rights expedited by Board under certain conditions. NRS 213.035
- District attorneys to furnish Board with statement upon receipt of notice of application for remission, commutation or pardon; notice of application to victim. NRS 213.040



# Pardons Board Statutory Duties

- ☐ Procedure when death penalty is commuted. NRS 213.080
- ☐ Board prohibited from commuting sentence of death or imprisonment for life without possibility of parole to a sentence that would allow parole; exception. NRS 213.085
- ☐ Pardon: Restoration of civil rights; relieved of disabilities; limitations. NRS 213.090
- □ Notice by Board to victim if clemency granted. NRS 213.095



## Pardons Board Regulatory Procedures

- ☐ Meetings. NAC 213.020
- ☐ Chair. NAC 213.030
- ☐ Availability and submission; time limit. NAC 213.040
- ☐ Contents: applicability. NAC 213.050
- ☐ Procedures and criteria for selection of applications for consideration by Board; additional selections. NAC 213.055
- Pardons: Waiting period for eligibility to submit application; waiver NAC 213.065
- □ Pardons: Investigation of applicant; rejection of application; list of rejected applications; written recommendation. NAC 213.073



# Pardons Board Regulatory Procedures

- ☐ Restoration of civil rights without Board meeting. NAC 213.077
- ☐ Prisoners eligible for or denied paroled. NAC 213.080
- □ Persons required to register as offender convicted of offense against child or sex offender. NAC 213.103
- ☐ Availability of judicial or administrative relief. NAC 213.107
- ☐ Commutation of sentence of life without possibility of parole. NAC 213.110
- ☐ Death penalty. NAC 213.120
- ☐ Requirements for reapplication. NAC 213.125

- □ Notice to certain persons of meeting to consider application; request for recommendations. NAC 213.185
- □ Notice to victim of meeting for consideration of clemency. NAC 213.187
- ☐ Hearings to be informal. NAC 213.190
- ☐ Testimony; presence of applicant; affidavits and depositions. NAC 213.200
- ☐ Preparation of official documents for clemency. NAC 213.205
