### Inmate Paschal-Campos

#### Sentence Structure:

Count II: 60 to 180 Months NDOC for Battery with Use of a Deadly Weapon Resulting in Substantial Bodily Harm

Count III: 16 to 72 Months NDOC for Burglary. This sentence is being ran concurrent to CT II.

She was found Not Guilty on Count I - Attempt Murder with Use of a Deadly Weapon.

#### Instant Offense:

Count II: 60 to 180 Months NDOC for Battery with Use of a Deadly Weapon Resulting in Substantial Bodily Harm

Count III: 16 to 72 Months NDOC for Burglary. This sentence is being ran concurrent to CT II.

- **Visitation:** (pre-CoVid19) for this facility is three (3) days per week; Monday, Tuesday and Thursday. Effective April 13 2020, due to COVID-19 the ADCRR has suspended both legal and non-legal visitation through October 13, 2020, at which time the suspension will be reevaluated.
- **Facility:** The facility in which she is housed is the ASPC Tucson, Minors Unit in Arizona, this is an Arizona state-run facility.
- **Cost:** There is no monetary exchange with ISC inmates. We are on a man per day basis. Arizona has two (2) NDOC inmates, and the NDOC currently has two (2) AZDOC (Arizona Department of Corrections) inmates in our custody.
