V. Discussion of Proposed Bill Draft Requests (BDRs) Selected at the October 13, 2020, Meeting

A. BDR 6: *This bill would require a school counselor, or school nurse or resource officer depending on the availability of resources, to annually screen each pupil in a public school for major depressive disorder, anxiety, and substance use. This bill would authorize a counselor to refer a pupil to a mental health professional as a result of the annual screening.*

B. BDR 13: *This bill would require all workers in the juvenile justice system, including, without limitation, judges, probation staff, prosecutors, public defenders, and school resource officers, to take trainings on implicit bias and cultural competency. This bill would also require the race of a juvenile to be redacted on the police report and not otherwise made available to a prosecutor when making a charging decision regarding a juvenile.*
