Legislators will also receive information on the roles of the Department of Health and Human Services (DHHS) and local governments. In the second part of this session, legislators will receive information on economic development programs in Nevada. The session will cover Nevada's Commission on Economic Development (NCED), county and regional development authorities, and partners in such key areas as education, renewable energy, and workforce development. Legislators will learn about recent accomplishments in global business development as well as other economic strategies employed by NCED. Legislators will be briefed on strengths, weaknesses, and current issues in the economic development environment.

# 1:30 p.m. — Public Employees: Benefits, Retirement, and Collective Bargaining

At this briefing, legislators will receive information on the Public Employees' Benefits Program (PEBP) and how the budget shortfall is being shifted to active employees and retirees either through decreased benefits or increased premiums.

In the second part of this session, legislators will receive an overview of the Public Employees' Retirement System of Nevada (PERS), which is a tax-qualified defined benefit plan that provides retirement and disability benefits to State employees, police and firefighters, nonprofessional staff of the Nevada System of Higher Education, county and city employees, and school district and other local district employees. The Legislature oversees PERS, although PERS has an independent board with an executive director and staff who handle day-to-day operations. The Legislative Retirement System is one of two additional retirement systems overseen by PERS for a specific group of public employees. The other system, the Judicial Retirement System, includes Supreme Court and District Court Judges, as well as local judges. The presentation will include PERS' structure, benefit design, eligibility requirements, and contribution rates and mechanisms, and the unfunded liability payment.

The final part of this session will cover the statutes and issues relating to collective bargaining for local governments and their employees. The presentation will include the formation of employee bargaining units, the role of the Local Government Employee-Management Relations Board, mandatory and permissive subjects of collective bargaining, and the dispute resolution processes.

The session will conclude with a review of the anticipated timeline for reapportionment and redistricting during the 2011 Legislative Session and an overview of the findings and recommendations of the Legislative Commission's Committee to Study the Requirements for Reapportionment and Redistricting (Assembly Concurrent Resolution No. 19, File No. 76, *Statutes of Nevada 2009*).
