"Quick Facts": Supplemental Nutrition Assistance Program (SNAP)

Program:

The Supplemental Nutrition Assistance Program formally the Food Stamp Program helps low-income people buy the food they need for good health. Benefits may be available to those who: work for low wages; are unemployed or work part time; receive welfare or other public assistance payments; are elderly or disabled and live on a small income; or are homeless.

The amount of assistance received for this federally funded program is based on the USDA Thrifty Food Plan, which is an estimate of how much it costs to buy food to prepare nutritious, low-cost meals for a household. The estimate is updated every year to keep pace with food prices. For most households, benefits are only part of their food budget; they must spend some of their own cash along with their benefits to buy enough food for a month.

Eligibility:

Applicants must (1) be a resident of Nevada (2) be a U.S. Citizen or qualified alien: (3) have a Social Security number and (4) cooperate with work requirements. On March 16, 2009 Nevada implemented the Broad Based Categorical Eligibility option to allow individuals be at or below 200% of the federal poverty level to qualify.

Trends

Multiple outreach efforts and increased economical needs have increased SNAP participation in Nevada. The state participation rate reported for 2008 was 52%, one of the lowest in the country. From January 1, 2008 through October, 31, 2009 there was a 79.26% increase in Nevada SNAP participants.
