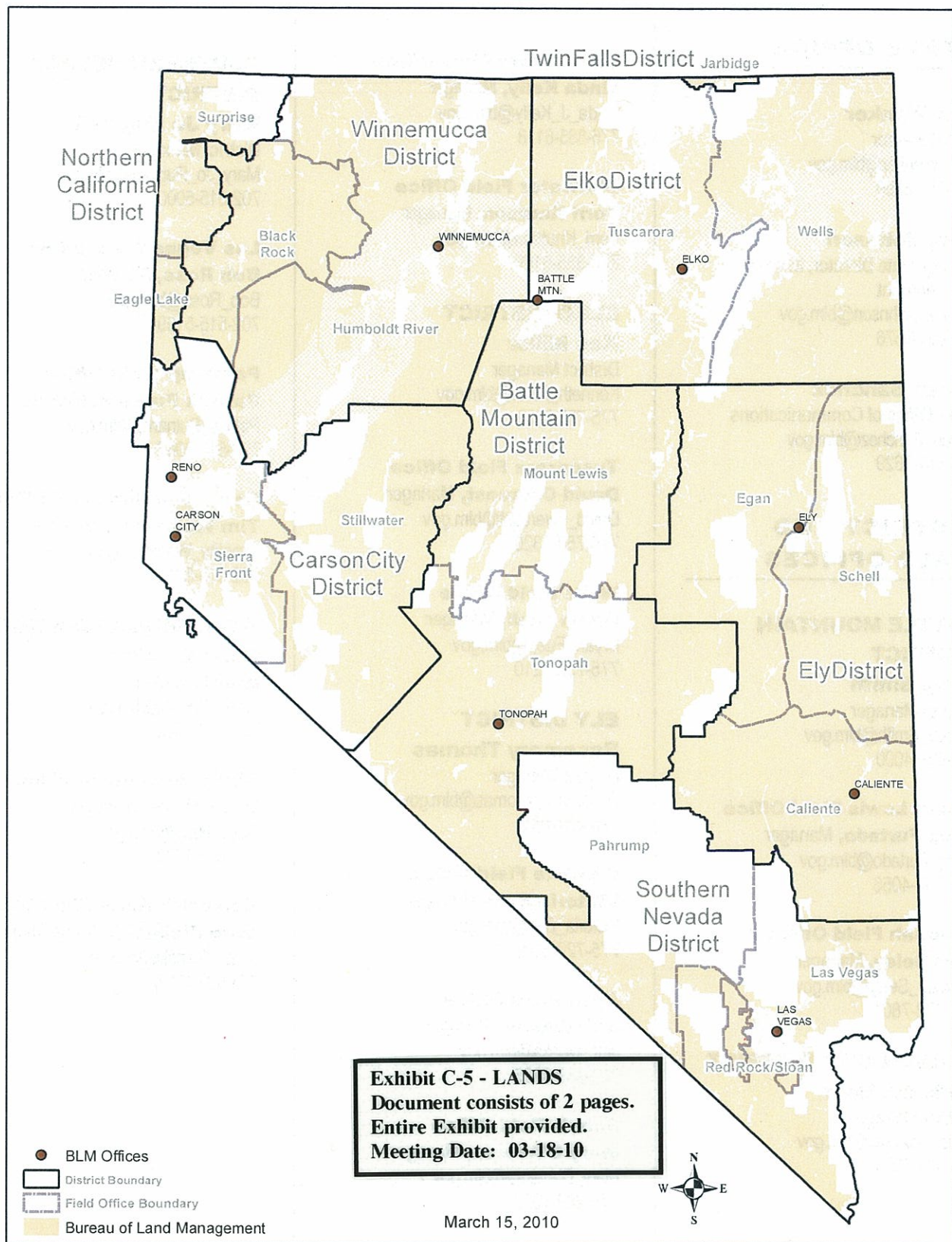


Bureau of Land Management Nevada, District and Resource Area Boundaries
