1. Police Records Management System – will allow all Nevada Law Enforcement Agencies that participate in the system to exchange Police Records Systems electronically (Stimulus Funding)
2. Fusion Centers – Las Vegas, Washoe, State (Homeland Security)  
Nevada Shared Gang Intelligence System (JAG Grant)  
RISS Intelligence Sharing Systems and De-confliction programs  
FBI-LEO Information Sharing System
3. LEXIPOL Policy Program will standardize the basic police policies throughout Nevada's law enforcement agencies so that we are all working off of the same policy to reduce liability and increase professionalism (Stimulus Funding)

## **Deficiencies in the Nevada Law Enforcement System**

- 1. Staffing – under that current economic conditions, many agencies are seeing their staffing levels reduced. This trend is will continue into the future as the economy struggles to recover. Some of the small rural agencies are seen reduction in staff as much as 25%.**
- 2. Training – Nevada spends about \$126.00 per year per officer for training. Again as the economy struggles, so will our ability to train struggle. We believe that there are adequate financial resources available if they were used for the purpose for which they are collected. Each citation has attached to it an administrative assessment fee which is used to help pay for the courts, police training and criminal records repository. Unfortunately, for years, these budgets have been reduced by the administration and legislature and the funds that should have been going to these programs have been going to the general fund for things other than what the assessment fee was collected for.**
- 3. Radio Inner-Operability – We are still struggling with the inability to communicate between agencies even after the disaster of 9-11. It seems like there is a lot of discussion and little action.**
- 4. Adequate Jail and Court Facilities – through out our State, we seen a number of jail facilities that are in dire need of replacement. We are operating a number of county jails and court houses that are 40-50-60 years old and in need of replacement. We have one jail that is still in use after 103 years.**
