Meeting Dates and Future Agendas

This memorandum presents a recommended schedule of meeting dates for the Nevada Vision Stakeholder Group¹ (NVSG) and an overview of future agendas. The NVSG may wish to approve the recommended schedule, with or without modifications.

On December 15, 2009, staff asked the NVSG members and alternates to indicate their availability for possible meeting dates between the initial meeting on January 8 and early May 2010. Based on the responses received, the staff tested various combinations and recommends the following dates, which appear to minimize the adverse effects of the schedule on individuals and the NVSG as a whole:

The NVSG may wish to select one of those dates or a different date in early May.

With the assistance of the consultant, the NVSG will carry out its assigned tasks in three main phases: (1) identifying quality-of-life (QOL) factors and measurement metrics; (2) identifying targeted factors and goals and strategies for improving them; and (3) making recommendations for implementing those strategies over 5-, 10-, and 20-year horizons. Thus, the structure of agendas for all NVSG meetings may be roughly as follows:
