1. Description of Independent Contractor Labor Service Provided:  Beginning on or about, BP Developers, Inc. hereby agree to provide temporary and/or full time independent contractor labor for the Company.
2. Performance of Service Provided:  The performance of the independent contractor labor services will be managed and directed by the Company on an "as needed" basis. The Company will be solely responsible for the quality and sufficiency of the workmanship rendered as a result of the independent contractor labor services and shall constitute a full release of all liability to BP Developers, Inc. The Company shall have sole liability and responsibility for the end result or "finished product" provided by the independent contractor labor services of BP Developers, Inc.
3. Payment:  Payment will be made by the Company to BP Developers, Inc. on a weekly basis at a rate of labor plus% for all labor services provided. This rate is locked in until Failure of the Company to pay BP Developers, Inc. in a timely manner, unless otherwise arranged, will constitute a breach of this Contract.
4. Accounting: The Company shall on a weekly basis provide BP Developers. Inc. records to worify.

The Company shall on a weekly basis provide BP Developers, Inc. records to verify the amount of labor services performed by the independent contractor. Policies and procedures for said records will be provided to the Company by BP Developers, Inc. in writing prior to the beginning of labor services and shall be considered an Addendum to this Contract.

#### 5. Obligations:

The Company agrees to the following obligations:

Comply with industry standards in providing a safe working environment; Encourage and enforce compliance with OSHA Regulations which are standard to the industry relative to the labor services being provided;

Conduct weekly safety meetings, and provide BP Developers, Inc. with documentation of said meetings;

Report any injuries which occurred to the independent contractor while on the Company's job site, to BP Developers, Inc., within 24 hours after such occurrence; Pay any fines or damages that may be initiated by OSHA, or any other party, against BP Developers, Inc. for work completed by the Company; and provide light duty work, as required, for injured independent contractor, or reimburse BP Developers, Inc. for the cost of non-medical expenses for any injured independent contractor who is eligible for light duty work.

BP Developers, Inc. agrees to the following obligations: Provide independent contractor labor services to the Company on an "as needed" basis.

#### 6. Indemnification:

BP Developers, Inc. agrees to indemnify and hold harmless the Company from any and all claims from government agencies regarding the use of Independent Contractors. This includes any lawsuits, demands, penalties, interest, actions, and/or sanctions that could be brought against the Company by any agency as a result of using the independent contractor labor services of BP Developers, Inc. BP Developers, Inc. and the Company agree that the Independent Contractor is in fact an Independent Contractor and in no way an employee of the Company.

The Company shall not allow any independent contractor to commence work on any Company job site until the Company has verified with BP Developers, Inc. that the independent contractor is eligible and has current paperwork on file with BP Developers, Inc.

Each party has read, understood, and agrees to the terms of this Contract. Each party understands that this Contract is fully enforceable if and when it is signed.

#### 11. Attorney's fees:

If either party to this Contract commences an action against the other party arising out of or in connection with this Contract, the prevailing party shall be entitled to have an recover from the losing party reasonable attorney's fees and costs of suit.
